# KIDDIE ACADEMY DAYCARE FACILITY

Issue: Mounting heights of fixtures in toilet rooms designed for children.

Analysis: The applicant is requesting a waiver from installing toilet fixtures in children's toilets in day care facilities. The project has been referred to the Commission because Chapter 11 makes no specific provision for toilets used for this purpose. This is a new, \$1,412,000 building and in addition to the classroom toilet rooms, toilets complying with the code and usable by staff and the public are available. The applicant has expressed interest in using the Guidelines for Children's Facilities adopted by the Access Board and Department of Justice.

## **Project Progress:**

The project is under design.

### Items to be Waived:

Toilet room mounting heights.

- 11-4.16.3 Height. The height of water closets shall be 17 inches to 19 inches measured to the top of the toilet seat.
- 11-4.19.2 Height and clearance. Lavatories shall be mounted with the rim or counter surface no higher than 34 inches above the finish floor.

Waiver Criteria: There is no specific guidance for a waiver of this requirement in the code. The Commission's current rule, authorized in Section 553.512, Florida Statutes, provides criteria for granting waivers and allows consideration of unnecessary or extreme hardship to the applicant if the specific requirements were imposed.
