- a. Per KONE on November 28, 2005: The cost of a single exterior water-resistant two-stop traction elevator is approximately \$450,000. The cost of providing vertical access to all slides would be over 50% of the total slide cost.

The inclusion of exterior elevators to all slide platforms is not only a substantial initial cost as stated above but also a significant maintenance cost. The inclusion of elevators is also a unique hardship for water slides as indicated by the inclusion of water slides as a general exception to accessible areas per the Americans with Disabilities Act Accessibility Guidelines for Buildings and Facilities, September 2002.
