THURSDAY, JUNE 5, 2014

MEETING SUMMARY AND OVERVIEW

At the Thursday, June 5, 2014 Product Approval Program Oversight Committee (PA POC) teleconference meeting there were only three of six appointed PA POC members available to participate, and as a result a quorum was not achieved and no PA POC business was conducted. It was explained to participants that although there would not be a June 2014 PA POC meeting or recommendations from the PA POC, the Commission as the decision-making entity has the authority to make the decision on the pending petition for a declaratory statement (DS2014-052) and for pending Product and Entity approvals without a PA POC recommendation. The Commission is meeting next on June 20, 2014 at the World Golf Village in St. Augustine, Florida. The public was informed that participation at Commission meetings must be done in person, although the meeting may be viewed live via streaming video. Participants with issues pending before the Commission are encouraged to attend the meeting.

It was further explained that there would be no delay in the review process for the declaratory statement and product and entity approvals since the Commission routinely makes all decisions on POC and TAC recommendations at their next scheduled Commission meeting subsequent to the relevant POC/TAC meeting. Finally, participants were informed that all of the procedural and discussion items scheduled for the June 5, 2014 PA POC Agenda would be deferred to the August 7, 2014 PA POC meeting, conducted in Tallahassee and via teleconference/web.
