BREVARD HIGH SCHOOL CCC AUDITORIUM

Issue: Vertical accessibility to all rows of seats in a high school auditorium.

Analysis: The applicant is requesting a waiver from providing vertical accessibility to all rows of seats in a new, 869 seat auditorium. 15 wheelchair seating locations at the front and rear of the facility are planned, but not all accessible seating areas have an adjacent companion seat. Some accessible seats are also placed on the ends of the rows. No estimates have been provided as the applicant contends it is technically infeasible to make all rows accessible.

Project Progress:

The project is under construction.

Items to be Waived:

Vertical accessibility to all rows of seats, as required by Section 553.509, Florida Statutes.

- 553.509 Vertical accessibility. Nothing in Sections 553.501-553.513 or the guidelines shall be construed to relieve the owner of any building, structure or facility governed by those sections from the duty to provide vertical accessibility to all levels above and below the occupiable grade level regardless of whether the guidelines require an elevator to be installed in such building, structure or facility, except for:
 - (1) Elevator pits, elevator penthouses, mechanical rooms, piping or equipment catwalks and automobile lubrication and maintenance pits and platforms;
 - (2) Unoccupiable spaces, such as rooms, enclosed spaces and storage spaces that are not designed for human occupancy, for public accommodations or for work areas: and
 - (3) Occupiable spaces and rooms that are not open to the public and that house no more than five persons, including, but not limited to equipment control rooms and projection booths.

Waiver Criteria: There is no specific guidance for a waiver of this requirement in the code. The Commission's current rule, authorized in Section 553.512, Florida Statutes, provides criteria for granting waivers and allows consideration of unnecessary or extreme hardship to the applicant if the specific requirements were imposed.

We do not believe that this type of construction (accessible seating in every isle of an Auditorium) was contemplated by the legislation in the drafting and implementation of the law for vertical accessibility. The statute itself would impose a hardship on the applicant that is unique to this situation and more specifically its user. The Florida Building Code, in section 11-4.33.3 states that - "Wheelchair areas shall be an integral part of any fixed seating plan and shall be provided so as to provide people with physical disabilities a choice of admission prices and lines of sight comparable to those for members of the general public. They shall adjoin an accessible route that also serves as a means of egress in case of emergency. At least one companion fixed seat shall be provided next to each wheelchair seating area. When the seating capacity exceeds 300, wheelchair spaces shall be provided in more than one location. Readily removable seats may be installed in wheelchair spaces when the spaces are not required to accommodate wheelchair users." Under the Exception in the same section it also states: "Accessible viewing positions may be clustered for bleachers, balconies, and other areas having sight lines that require slopes of greater than 5 percent. Equivalent accessible viewing positions may be located on levels having accessible egress." It is financially impracticable to provide vertical accessibility to every aisle of seating in the Auditorium. With this in mind we have worked toward providing dispersed accessible seating in the front and rear areas of the Auditorium per FBC section 11-4.33.3 and its exception. We believe that this viable solution will meet the concerns and needs of all the Council, the Commission and especially guests with

[X] Substantial financial costs will be incurred by the owner if the waiver is denied.

This is due to the costs that would be required by the accessible design requirements of the FACBC and the ADA. In addition, the Auditorium would have to be much larger to accommodate the same number of seats, further increasing the construction cost. 
