Mr. Blair welcomed everyone to the teleconference of the Accessibility TAC. He provided information for the callers on how to mute systems to avoid background noise.

Roll Call:

Legal Status:

Mr. Vogel stated that he has previously spoken with the TAC regarding the legal status of the Florida Accessibility Code, but thought it might be helpful to give a review, since the general comment submitted speaks on this code.

Mr. Vogel advised that the Florida Legislature has specified what provisions will constitute the Florida Accessibility Code, and those are a collection of federal requirements and some state provisions. He further stated that the Commission is specifically prohibited from revising or amending those standards, so it probably would not be able to incorporate any accessibility-related provisions that the commenter is requesting. Mr. Vogel stated the commenter would need to go through the Legislature in order to have those changes included in the accessibility code.
