Commissioner Smith stated he feels leaving this as a choice is the best option.

Mr. Sanders stated that there should be as many options as possible for the builders and owners.

It was determined that the section 405.6.1's exception will need to be updated for the proposal to the Commission, and Mr. Belcher stated he will provide the necessary updated language for the Commission.
