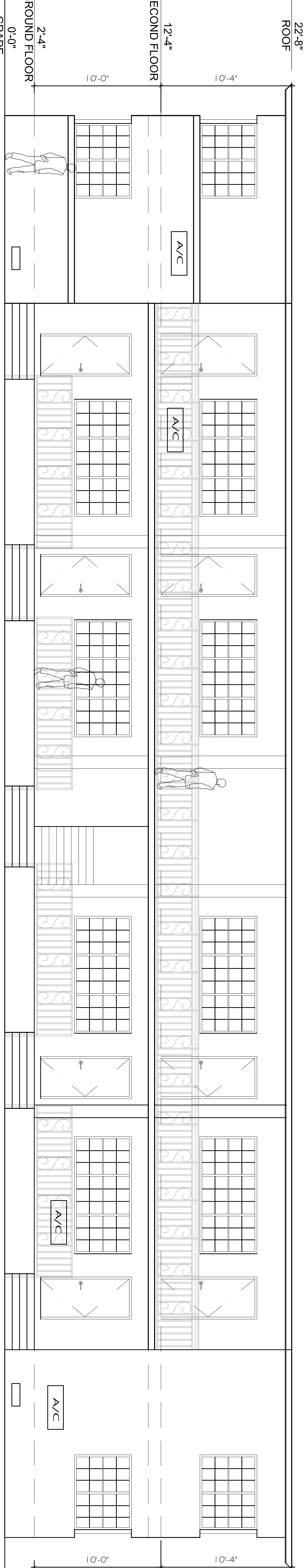

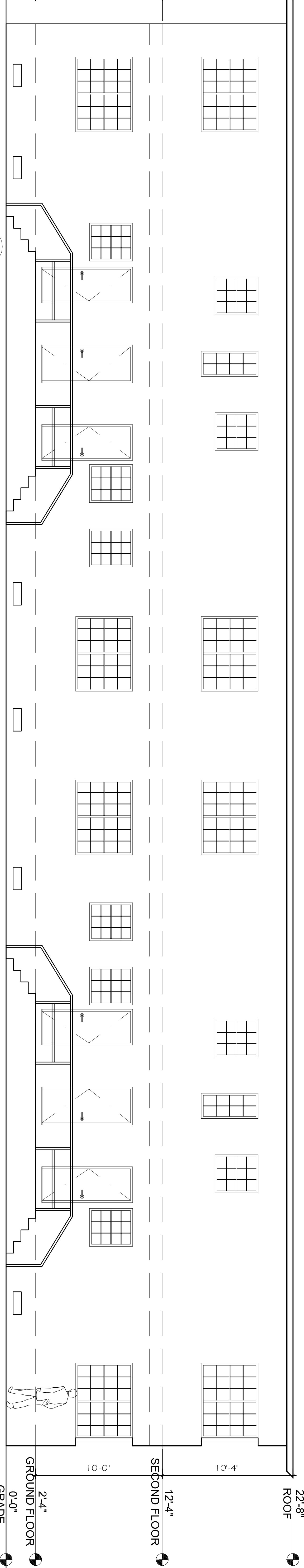


1 SOUTH ELEVATION

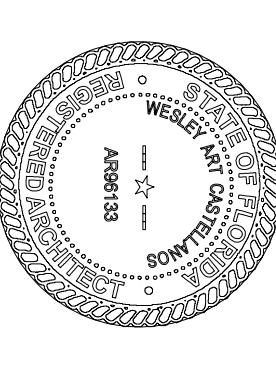
