ANNOTATIONS

Purpose:

Authority Having Jurisdiction, Mr. James R. Johannessen, AIA, Hillsborough County Public Schools, Building Code Official, has disagreed with the Florida Building Code Informal Interpretation which was issued on September 17, 2007; Report #5321 (attached hereto) and has requested that petitioner seek a formal declaratory statement. It has been Mr. Johannessen's position that the required emergency escape and rescue windows must open out "in the direction of exit travel". Petitioner has contended that such would have been the case if the windows had been designed to serve as "secondary exits" as had formerly been required under the Standard Building Code, however, it has been the petitioner's opinion that, under FBC Section 1025, a second exit is not required in a classroom with fewer than 50 occupants, and that an emergency rescue window may open in or out or up (as shown in the FBC Commentary), provided dimensional criteria are met.

Question:

Is it the intent of Section 1025.4.1 to require that the rescue panel swing out (in the direction of travel) if using a casement window? Comment: Section 1025 is completely consistent the NFPA 101 with regards to emergency rescue openings. Neither code states that the window would have to open out. Since these are no longer used for a "secondary means of egress" in schools and the Code specifically states you need a sign saying "Emergency Rescue - Keep Area Clear" it would seem that it does not matter which way the window swings.

They could swing in or out or roll up provided all the dimensional critera is met.
