#### **Declaratory Statement:**

#### DS 2018-016 by Angela Petrakis of Diversified Window Solutions Inc.(Seperately)

Mr. Madani provided the background for DS 2018-016 combined with the following staff analysis and response for the TACs for consideration.

#### **Question:**

Does this Hazardous location apply to Exterior Doors only adjacent to Exterior Windows or does this Condition apply to Interior Doors as well adjacent to Exterior Windows?

#### Answer:

For the project in question and as per Section 2406.4.2, Exception 4, of the 6th Edition (2017) Florida Building Code, Building, the hazardous location requirements of Section 2406.4.2 is only applicable to windows adjacent to exterior doors.

#### TAC questions and discussion:

Mr. Schiffer and Mr. Belcher both stated the exception does not exclude all interior windows and requested an update to the staff answer.

Mr. Schwab stated he disagreed with this and stated the staff response was correct.

Mr. Schiffer entered a motion to change the staff response to two questions with two answers removing "or" and should read:

## **Questions:**

- 1. Does this Hazardous location apply to Exterior Doors only adjacent to Exterior Windows?
- 2. Does this Condition apply to Interior Doors as well adjacent to Exterior Windows?

## Answers:

- 1. No.
- 2. Yes, per Chapter 24.

Mr. Belcher seconded the motion. The motion passed with 6 members in favor and 1 member against.
