THE MERCATO

Issue: Vertical accessibility to all rows of seats in a multi-theater movie complex.

Analysis: The applicant is requesting a waiver from providing vertical accessibility to all rows of seats in a new \$4.5 million theater complex located on the second floor of the build out of a two story mixed use building. Plans submitted indicate that the appropriate number of wheelchair locations and companion seating are planned on the first level of the stadium style seating. No actual estimates of the cost to provide vertical accessibility were submitted; however, a contractor's letter indicated it would be cost prohibitive and likely eliminate the financial ability to fund the project. In addition to the theaters, the project will include concessions, kitchen, dining room/lounge, toilet rooms and administrative and employee facilities.

Project Progress:

The project is under design.

Items to be Waived:

Vertical accessibility to all rows of seating, as required by Section 553.509, Florida Statutes.

- 553.509 Vertical a ccessibility. Nothing in Sections 553.501-553.513 or the guidelines shall be construed to relieve the owner of any building, structure or facility governed by those sections from the duty to provide vertical accessibility to all levels above and below the occupiable grade level regardless of whether the guidelines require an elevator to be installed in such building, structure or facility, except for:
 - (1) Elevator pits, elevator penthouses, mechanical rooms, piping or equipment catwalks and automobile lubrication and maintenance pits and platforms;
 - (2) Unoccupiable spaces, such as rooms, enclosed spaces and storage spaces that are not designed for human occupancy, for public accommodations or for work areas; and
 - (3) Occupiable spaces and rooms that are not open to the public and that house no more than five persons, including, but not limited to equipment control rooms and projection booths.

Waiver Criteria: There is no specific guidance for a waiver of this requirement in the code. The Commission's current rule, authorized in Section 553.512, Florida Statutes, provides criteria for granting waivers and allows consideration of unnecessary or extreme hardship to the applicant if the specific requirements were imposed.

[x] The hardship is caused by a condition or set of conditions affecting the owner which does not affect owners in general.
Strict interpretation of section 11.4.2.6.1.k.iii requires the owner to provide vertical accessibility to all levels above or below a habitable grade. However we do not believe that this type of building was contemplated by the legislation in the drafting and implementation of the law and that the statute itself would impose a hardship on the applicant that is unique to the situation and more specifically its use, nor that they meant every level of stadium seating. It is
impossible to provide vertical accessibility to each level of stadium seating. This is due to the costs and the requirements of the FACBC and the ADA (They {the seating} shall adjoin an accessible route that also serves as a means of egress in case of emergency). This cannot be
accomplished in a stadium seating environment.












AUDITORIUM 1 ALL SEATS FLOOR PLAN


