OVERVIEW OF COMMISSION'S KEY ACTIONS AND DECISIONS

Tuesday, April 9, 2013

WELCOME

Chairman Browdy welcomed the Commission, DBPR staff and the public to St. Augustine and the April 9, 2013 plenary session of the Florida Building Commission. The Chair noted the primary focus of the April meeting, in addition to considering regular procedural issues including product and entity approvals, applications for accreditor and course approvals, petitions for declaratory statements, accessibility waivers, and recommendations from the Commission's various committees, was for the purpose of considering and deciding on issues and recommendations for inclusion in the Commission's 2012-2013 Annual Report.

The Chair noted that there were buff colored "Public Comment Forms" on the speakers' table to be used for providing written comments, and all written comments would be included in the Facilitator's Summary Report.

The Chair explained that if one wished to address the Commission on any of the issues before the Commission they should sign-in on the appropriate sheet(s), and as always, the Commission will provide an opportunity for public comment on each of the Commission's substantive discussion topics. The Chair explained that if one wants to comment on a specific substantive Commission agenda item, they should come to the speaker's table at the appropriate time so the Commission knows they wish to speak. The Chair noted that public input is welcome, but should be offered before there is a formal motion on the floor.

Chairman Browdy explained that some of the licensing boards {Board of Architecture and Interior Designers; Building Code Administrator and Inspector Board; Construction Industry Licensing Board; Electrical Contractors Licensing Board, and Board of Professional Engineers} located within the Department of Business and Professional Regulation, have adopted rules regarding continuing education credits for attending Florida Building Commission meetings and/or Technical Advisory Committee meetings. Participants whose board participates may sign-in on the laptop kiosk station located in the meeting room.

I. PLENARY SESSION SUMMARY AND OVERVIEW

At the April 9, 2013 meeting the Commission considered and decided on Chair's issues and recommendations, product and entity approvals, applications for accreditor and course approvals, petitions for declaratory statements, accessibility waivers, recommendations from the Commission's various committees, and discussed the results of the annual *Workplan Prioritization Exercise* and *Effectiveness Assessment Survey*. Specific actions include: the Commission referring a request from the Building Code Advisory Board of Palm Beach County regarding corrosion of roof fasteners to the Roofing TAC for evaluation; voting to maintain March 1, 2014 as the effective date for the 2013 Florida Building Code; voting to notice a supplemental rule development workshop for Rule

61G20-4.001, Procedures – Accessibility Waiver Fees, tasking the Accessibility TAC with developing recommendations on a fee, and holding the supplemental rule development workshop in August and a rule adoption hearing in October; voting to adopt the settlement as set forth in the Settlement Stipulation, by entry of a final order of the Florida Building Commission adopting the Settlement Stipulation regarding DOAH Case Nos. 13-580 and 13-769; and, deciding on and approving recommendations developed from the *Building Code System Uniform Implementation Evaluation Workgroup* (BCSUIE) process. Finally, the Commission approved the Summary of Issues and Recommendations for inclusion in the Commission's 2012-2013 Annual Report.

WORKPLAN PRIORITIZATION EXERCISE

Jeff Blair reviewed the results of the 2013 Workplan Prioritization Exercise and answered member's questions. Commissioners were asked to rank each of eight (8) key *Workplan Tasks* on a five-point continuum/scale where a 5 equals the highest level of priority and a 1 equals the lowest level of priority. Members were asked to rank the priority of each task independently and not in relation to the other tasks. Each of the *Workplan Task's* rankings were tallied and arranged in order of highest priority (1) to lowest priority (10). The ranking results ranged from a high of 4.57 to a low of 3.14 out of 5.

VI. EFFECTIVE DATE OF THE NEXT EDITION OF THE FLORIDA BUILDING CODE

Mo Madani, DBPR Code Technical Manager, reviewed a proposed revised effective date and related implementation schedule for the 2013 Florida Building Code with the Commission, and answered member's questions. Mo noted that staff is recommending the effective date for the 2013 Code be changed from March 1, 2014 to December 31, 2014 to sync with the effective date of the Florida Fire Prevention Code and to provide adequate time to prepare a fully integrated updated Code.

Chairman Browdy reported that the Commission should consider allowing the 2013 Code once adopted to be used on a voluntary basis as an alternate equivalent to the current edition of the Code prior to the effective date of the 2013 Code. The Chair noted the Commission should consider this action when they formally adopt the 2013 Florida Building Code.

Following questions and answers, public comment and discussion the Commission took the following action:

Commission Action:

MOTION—The Commission voted, 16 - 3 in favor, to maintain the March 1, 2014 effective date of the 2013 Florida Building Code, and for staff to revise the Workplan to reflect this schedule.

MOTION—The Commission voted unanimously, 19 - 0 in favor, to approve advanced course #573.0.

MOTION—The Commission voted unanimously, 19 - 0 in favor, to approve the following administratively approved updated advanced courses on a consent agenda: #170.1, #175.1, #178.1, #173.1, and #176.1.

MOTION—The Commission voted unanimously, 19-0 in favor, to defer approval of self-affirmed advanced course #317.1 (based on the citing of the 2007 version of the Florida Building Code instead of the 2010 version, both on the course syllabus and on numerous slides throughout the actual course materials).

MOTION—The Commission voted unanimously, 19 - 0 in favor, to approve self-affirmed advanced course #484.0.

Petitions For Declaratory Statements

MOTION—The Commission voted 18 - 0 in favor, to approve the Code Administration and Special Occupancy TACs' recommendation on the petition.

XI. PROPOSED RULEMAKING RULE 61G20-4.001, PROCEDURES – ACCESSIBILITY WAIVER FEES

Chairman Browdy noted Section 553.512 (1) provides that the Commission shall establish by rule a fee to be paid upon submitting a request for an Accessibility Code waiver. The Commission voted to initiate rulemaking in October of 2010 to establish fees for waiver applications but the initiative was delayed due to administrative and logistical issues associated with the Governor's directive regarding rulemaking and scheduling issues. FBC Executive Director Jim Richmond provided the Commission with an overview of the issue regarding Rule 61G20-4.001, Procedures, Accessibility Waiver Fees and staff's recommendations going forward. Jim reported that JAPC contacted staff to inform them that the rule is yet to be implemented per statutory direction and noted that the Commission should proceed with rule development. Jim noted that staff recommended the Commission proceed with rulemaking for Rule 61G20-4.001, Procedures – Accessibility Waiver Fees, by conducting a supplemental rule development workshop at the August 2013 meeting and a rule adoption hearing at the October 2013 meeting. In addition, the issue of recommending a fee should be referred to the Accessibility TAC for their evaluation and recommendation to the Commission. Following questions and answers, public comment and Commission discussion, the Commission took action as follows.

In response to JAPC comments and DBPR staff recommendations the Commission took the following actions:

Commission Action:

MOTION—The Commission voted unanimously, 18 - 0 in favor, to notice a supplemental rule development workshop for Rule 61G20-4.001, Procedures – Accessibility Waiver Fees, tasking the Accessibility TAC with developing recommendations on a fee, and holding the supplemental rule development workshop in August 2013 and a rule adoption hearing in October 2013.

XII. BINDING INTERPRETATION #91; BEACHLEN DEVELOPMENT COMPANY, LLC v. DBPR AND THE FLORIDA BUILDING COMMISSION, DOAH CASE Nos. 13-769 AND 13-580

The Chair reported that at the February 2013 meeting staff reported that an appeal of Binding Interpretation #91 (petition challenging interpretation) issued by BOAF on the 2007 Florida Building Code, Building, Section 3109—Coastal Construction Control Line (CCCL) requirements, had been received by the Commission with a request for a Petition for Formal Administrative Hearing. At the April 2013 meeting Kyle Christopher (DBPR litigation counsel) presented a proposal for resolution in the form of a Settlement Stipulation between Beachlen Development Company, LLC and DBPR and the Florida Building Commission regarding DOAH Case Nos. 13-580 and 13-769. Following questions and answers, public comment and Commission discussion, the Commission took the following action:

Commission Action:

MOTION—The Commission voted unanimously, 19 - 0 in favor, to adopt the settlement as set forth in the Settlement Stipulation by entry of a final order of the Florida Building Commission adopting the Settlement Stipulation regarding DOAH Case Nos. 13-580 and 13-769.

Following questions and answers, public comment, and Commission discussion, the Commission took the following actions:

Commission Actions:

MOTION—The Commission voted unanimously, 17 - 0 in favor, to recommend to the Florida Legislature that a definition of the term "local technical amendment" be added to Chapter 553.73, F.S., as follows: "An action by a local governing authority that results in a technical change to the Florida Building Code and its local enforcement."

MOTION—The Commission voted unanimously, 17 - 0 in favor, to recommend to the Florida Legislature that the Commission be granted statutory authority to interpret the Florida Accessibility Code for Building Construction consistent with the Commission's ability to interpret all of the other sections of the Code.

MOTION—The Commission voted unanimously, 17 - 0 in favor, that Chairman Browdy should work with DBPR staff to draft a letter to all of Florida's city and county attorneys, city and county managers and mayors regarding the statutory requirements contained in Section 553.73 (4)(b)(5.), F.S., requiring any amendment to the Florida Building Code: "shall be transmitted within 30 days by the adopting local government to the commission. The commission shall maintain copies of all such amendments in a format that is usable and obtainable by the public. Local technical amendments shall not become effective until 30 days after the amendment has been received and published by the commission."

MOTION—The Commission voted unanimously, 17 - 0 in favor, to adopt the Draft Summary of Issues and Recommendations for inclusion in the Commission's 2012-2013 Annual Report.

OTHER COMMISSION ACTION

There were no additional Commission actions.

XV. GENERAL PUBLIC COMMENT

- Calleja: a letter should be sent by the Commission to local building departments informing them that statutory requirements prevail over Code requirements, and the Glitch process provides a mechanism to revise the Code to correlate with statutory requirements.

The June 10 - 12, 2013 Commission meeting in Daytona Beach, Florida will focus on routine Commission procedural matters including Chair's issues and recommendations, updates of the Workplan, product and entity approvals, applications for accreditor and course approvals, petitions for declaratory statements, accessibility waivers, and recommendations from the Commission's various committees. The Commission will receive updates and discuss relevant legislative issues emerging from the 2013 Florida Legislative Session. The Commission will finalize issues for inclusion in the *Commissions 2012-2013 Annual Report*. The Commission will conduct a supplemental rule development workshop for Rule 61G20-4.001, Procedures – Accessibility Waiver Fees.

ATTACHMENT 3 FLORIDA BUILDING COMMISSION HISTORY AND OVERVIEW

HISTORY

Following Hurricane Andrew in 1992, Florida experienced record-breaking insurance losses resulting in a crisis affecting every homeowner in the state. The Governor appointed a Building Code Study Commission, The Florida Conflict Resolution Consortium designed and facilitated a two-year study and deliberation process with the 28 members representing a range of interests in the public and private sectors, through which the Commission evaluated the building code system.

The study revealed that building code adoption and enforcement was inconsistent throughout the state and even local codes thought to be the strongest proved inadequate when tested by major hurricane events. The consequences were devastation to lives and economies and a statewide property insurance crisis. The Commission recommended reform of the state building construction system which placed emphasis on uniformity and accountability.

The legislature enacted the consensus recommendations into law in 1998. In late 1998, the Consortium was asked by the Commission's chair to assist the newly created Florida Building Commission in its effort to build consensus for a uniform building code proposal. A complex consensus building process was put in place that included designing and facilitating meetings of 12 balanced technical advisory groups of 11 members each appointed by the Commission, as well as the Commission's meetings. The Consortium continues to work with the Commission by providing facilitation and consensus-building services.

OVERVIEW

The Florida Building Commission is a 25 member Governor appointed representative stakeholder group who successfully created, implemented, and maintains the new statewide Florida Building Code. The Commission is comprised of the Governor's Chair, and 24 members appointed according to criteria established by the American National Standards Institute (ANSI) for representation. They are as follows: in the general interest category: four code officials, two state government representatives, a local government representative, a representative of persons with disability; in the consumer category: an architect, a structural engineer, a mechanical engineer, representatives of fire protection technology, the building management industry, and the insurance industry; and in the producer category: a general contractor, residential contractor, mechanical contractor, plumbing contractor, electrical contractor, roofing/sheet metal/air conditioning contractor, a manufactured building representative, a building product manufacturer, a swimming pool contractor, and a representative of the green building industry.

The Florida Building Commission (FBC) seeks to develop consensus decisions on its recommendations and policy decisions. General consensus is a participatory process whereby, on matters of substance, the members strive for agreements which all of the members can accept, support, live with or agree not to oppose. In instances where, after vigorously exploring possible ways to enhance the members' support for the final decision on substantive decisions, and the Commission finds that 100% acceptance or support is not achievable, final decisions require at least 75% favorable vote of all members present and voting. This super majority decision rule underscores the importance of actively developing consensus throughout the process on substantive issues with the participation of all members and which all can live with and support. The Commission's consensus process is conducted as an open public process with multiple opportunities for the public to provide input to the Commission on substantive issues.

At each Commission meeting, the public is welcome to speak during the public comment period provided for each substantive issue under consideration, as well as general public comment periods provided at the end of each day's meeting. In addition, most substantive issues before the Commission go through a workgroup process where consensus recommendations are developed by appointed representative stakeholder groups, providing additional opportunities for public input. Workgroup recommendations approved by the Commission usually require rule development to implement, affording at least two additional entry points for public comment.

Since its formation in July of 1998, The Commission has demonstrated a commitment to working with affected interests to build consensus on complex issues. The adoption of the first edition of the Florida Building Code (2001 Edition), developed from September 1998 through January of 2001, involved 27 Commission meetings, many dozens of facilitated public workshops, and hundreds of TAC meetings. The Commission has consistently worked with all affected interests to build the best possible consensus-based decisions for the citizens of Florida.

Through its committees and workgroups of experts, the Commission has always developed its decisions on the results of the best engineering-based science available. Although the Code is by law a minimum building code, the Florida Building Code is the strongest consensus and science based building code in the country.

In summary, the Florida Building Commission provides a forum for stakeholders representing key interests to participate in a consensus-building process where issues affecting the construction industry are discussed and evaluated on their technical merits and cost-benefits to the citizens of the State of Florida. In addition, as a result of the Commission's proven consensus-building process and success in developing consensus on tough issues, the Florida Legislature annually assigns policy issues to the Commission for evaluation and implementation.

The Council reviewed and made recommendations for disposition of waivers for the following projects.

The Commission took the following actions regarding waivers.

Fifth Street Marina, 341 N. W. South River Drive, Miami

Issue: Vertical accessibility to the loft area of a marina warehouse undergoing an alteration.

Analysis: The applicant is requesting a waiver from providing vertical accessibility to a new, 1,600 square foot loft in an existing 5,000 square foot warehouse that has historically been used for marine industrial purposes. The owner plans to divide the building into two commercial studios and construct the new loft. There is an existing lift to convey patrons to the first floor level and quotes from \$88,867 to \$122,000 for elevators were provided. The overall construction cost of the project is estimated to be \$202,252; however, the building official stated that the building underwent a \$1,250,000 alteration during the previous three years, increasing the applicable cost for determining disproportionate cost to be \$1,454,252.

Recommendation: Deferral, for cost breakdown and clarification regarding proposed use of loft. COMMISSION ACTION: Deferred.

Holiday Surf and Racquet Club Condominium, 510 Gulfshore Drive, Destin

Issue: Design criteria for dune walkover.

Analysis: The applicant is requesting a waiver from providing a ramped dune walkover system in lieu of a stepped dune walkover costing \$40,534. According to the applicant, a ramped system would increase the cost of construction an additional \$79,600. The structure is being constructed as a result of a beach renourishment project adjacent to the property which is a resort condominium licensed under Chapter 509, F. S. It is also subject to regulation by the Department of Environmental Regulation (DEP), since the system will be installed seaward of the Coastal Construction Control Line. DEP will not permit a ramped system to be constructed because the size of the structure would create more impervious materials, subject to storm conditions, on the beach. The applicant plans to provide a beach wheelchair to maneuver on the sand after leaving the structure. The local building official does not consider the stepped system accessible, and referred the applicant to the Commission for a waiver. There are no Florida-specific requirements in the Accessibility Code that can be waived.

Recommendation: Deferral, to request additional information from applicant.

COMMISSION ACTION: Deferred.

Greater Tallahassee Chamber of Commerce, 300 Park Avenue, Tallahassee

Issue: Vertical accessibility to the second floor of an office building.

Analysis: The applicant is requesting a waiver from providing vertical accessibility to the second floor of an office building undergoing a \$75,000 alteration. Access to the second floor from the first is obtained via an interior stair. The project will also include adding a second stair to the upper offices to comply with egress requirements; making the entrance of the building accessible; modifying existing restrooms so they are accessible; and altering interior doors to provide 32" clear widths. Estimates of \$58,000 and \$37-39,000 were submitted as the cost to install an elevator to the second floor, which contains seven existing offices, a mechanical room and vacant storage space.

Recommendation: to grant, based on disproportionate cost.

COMMISSION ACTION: Granted.

Claremont Hotel, 1700 Collins Avenue, Miami Beach

Issue: Vertical accessibility to the first guest room level of a hotel.

Analysis: The applicant is requesting a waiver from providing vertical accessibility to the first guest room level of a historic hotel. The lobby is accessed from street level, and the first floor is elevated via a series of steps. According to the applicant, the stairway width is only 4'9" wide, and installation of a lift would encroach into the required clear egress space. The two upper level guest room floors are served by a passenger elevator and all required accessible guest rooms are located on accessible floors.

Recommendation: to grant, based on technical infeasibility.

COMMISSION ACTION: Granted.

Xtreme Pool Challenge, 161 N. Atlantic Avenue, Cocoa Beach

Issue: Vertical accessibility to all levels.

Analysis: The applicant is requesting a waiver from providing vertical accessibility to the entrance and to all levels of a 2800 square foot two story split level with three levels. The applicant plans to hold pool tournaments and has no accessible features currently in the building. The project consists of no alterations to the building. Estimates of \$100,000.00-\$125,000.00 and \$80,000.00 for an elevator was submitted and an estimate of \$54,300.00 for the shaft. The value of the existing building is \$170,000.00 to substantiate financial costs will be incurred by the owner if the waiver is denied.

Recommendation: no Council recommendation, split vote.

COMMISSION ACTION: Denied.

DECLARATORY STATEMENTS

PETITIONS FOR DECLARATORY STATEMENTS—APRIL 9, 2013

1.) DS 2013 – 001 by Ken Rich Question:

To the question": Since the stair design as shown in Diagram A, meets the guidelines of the Florida Building Code Sections R311.7.1 through R311.7.8 is it also required, in addition, to meet Florida Building Code, Residential, Section R311.7.9.3 of which, by definition, it is not.",

Answer: No. Section R311.7.9.3 of the Florida Building Code, Residential is an incomplete provision which provides for no requirement that would have any bearing on the project in question. Note: This answer should not be construed as an approval for the stair design indicated in Diagram 'A' of the DEC Statement.

COMMISSION ACTION: The Commission voted unanimously, 19-0 in favor, to adopt the Fire TACs' recommendation on the petition.

2.) DS 2013-011 by Robert Fine

Question #1: Are the areas of the apartment buildings and developments in projects that will be permitted and constructed by Petitioners in Florida, that are intended solely for the use of residents and their guests (including dwelling units and common use areas), that are not subject to Section 504 of the Rehabilitation Act (programs receiving federal financial assistance) and are not subject to Title II of the Americans with Disabilities Act (State and Local Government Services), subject to the Accessibility Code except for the requirement set forth in Section 553.504(2), Florida Statutes, as provided for in Section 101.1.3 and 201.1 of the Accessibility Code?

Answer: No. Pursuant to Section 553.507 (1-2), Florida Statutes, multifamily residential dwellings such as rental apartments and residential condominiums (and their associated common use areas) that are not the recipients of government financial assistance or sponsorship (federal, state or local), are not subject to the Accessibility Code, with the exception of Section 553.504(2), unless they are places of public accommodation or commercial facilities. An exception to this would be discrete areas contained within multifamily residential dwellings that fall within the definitions of "place of public accommodation" or "commercial facilities," such as a leasing or sales office and the restrooms and parking that support it (and the accessible route that connects these elements), such areas would be subject to the Accessibility Code unless otherwise exempted by the Accessibility Code.

Question #2: Are swimming pool that are part of common use areas of the apartment buildings and developments in the projects that Petitioners will be permitting and constructing, that are intended solely for the use of residents and their guests (and not otherwise available to the general public) and which are not the recipients of governmental financial assistance or sponsor ship, subject to the Accessibility Code because Section 424.1 classifies them as "public swimming pools" or any other reason?

Answer: No. The technical requirements of Section 424, Swimming Pools and Bathing Places (Public and Private), including the definition of "public swimming pools" or "public pools" of the 2010 Florida Building Code, Building are standalone/independent provisions which have no bearing on technical scope of the 2010 Florida Building Code, Accessibility. Further, according to the "Questions and Answers: Accessibility Requirements for Existing Swimming Pools at Hotels and Other Public Accommodation" as published by the U.S. Department of Justice (which may be relied upon pursuant to Section 553.503, Florida Statutes), the answer to the subject in question is as follows:

"Community pools that are associated with a private residential community and are limited to the exclusive use of residents and their guests are not covered by the ADA accessibility requirements. On the other hand, if a swimming pool/club located in a residential community is made available to the public for rental or use, it is covered under Title III of the ADA. If a community pool is owned or operated by a state or local government entity, it is covered by Title II of the ADA, which requires "program accessibility." See http://www.ada.gov/pools2010.htm. "

COMMISSION ACTION: The Commission voted unanimously, 19-0 in favor, to adopt the Accessibility and Swimming Pool TACs' recommendations on the petition.

3.) DS2013-013 by Robert Lorenzo

Question: Can storage sheds that are not designed for human habitation and have a floor area of 720 square feet (67m²) and built by an approved manufacturer in the Manufactured Building Program be inspected as finished buildings in the yard for shipping.

Answer: No. For the subject in question, storage sheds that fall within the 20 percent of those storage sheds that are required to be inspected as per Section 428.3.2.1 are required to be fully inspected during the manufacturing process.

COMMISSION ACTION: The Commission voted unanimously, 18-0 in favor, to adopt the Code Administration and Special Occupancy TACs' recommendations on the petition.
