Re: Petition For Declaratory Statement Before the Florida Building Commission

CLP Systems is an engineered shearwall holdown and uplift system using threaded rod material manufactured by our parent company. Every job is unique based on the loads the engineer specifies and the particular rod height and length. The rods are connected with standard couplers. We design the top plate washer based on the load. We provide the load of the rod, the washer, and the anchorage in our shop drawings.

CLP first contacted the FBC in 2009 when our company was entering the state of Florida. We wanted to obtain a product approval number for our system because our competitors (Hurri-Bolt, Tie-Max, Go-Bolt) had the approval and we believed it necessary. We were told that the FBC would no longer be evaluating engineered threaded rod holdown systems and we would not need one. We did in fact receive e-mails stating this fact from Mr. Madani we were able to use on occasion when asked for a product approval number. Unfortunately, we can no longer locate these e-mails and want to assure the ruling is the same now as in 2009.

From reading Chapter 61G20-3 Product Approval, I believe CLP and all our competitors as listed above fall outside the scope under Exception 61G20-3.003. It would appear our situation meets (1) (a) and (b) and perhaps (2) as well since the product is engineered to meet a performance specification by the engineer of record.

Our goal is to have this issue resolved so we are clear that CLP is in good standing providing our products and services in Florida without a Florida Product Approval Number. If this is deemed such, we wish for a blanket statement to be made to our competitors using the Florida Building Code as a marketing tool against CLP and for CLP to be provided an official statement letter we can show our customers that a Florida Product Approval does not exist for our product. Does CLP and engineered threaded rod shearwall holdown and uplift systems fall outside the scope of Rule 61G20-3?
