Hello Mo,

Keystone Certifications respectfully submits this email in response to the Department of Business & Professional Regulation (DBPR) request below.

Keystone suspended Quality Assurance Program licensure for Zion Tile of Miami, Florida on February 17<sup>th</sup> of this year as documented to the Florida DBPR in the attached email. The suspension was the result of Zion Tile's inability to provide Keystone with documents indicating conformance with program requirements.

The attached Inspection Report dated June 19<sup>th</sup>, 2014 identifies multiple quality management system procedural and record keeping deficiencies discovered during this inspection. Keystone Quality Assurance Program Policy requires the establishment of timeframes for licensee resolution of such deficiencies, but also specifies "Keystone may grant an extension of this designated timeframe based on a documented request from the licensee indicating the reason for the extension request and date the notice will be submitted." Several requests for extension of timeframe to demonstrate conformance were received from Zion Tile and granted by Keystone.

Of particular interest to the POC may be the deficiency detailed on page two of the report – the quarterly test reports indicating conformance with ASTM C1167, as required by the 2010 Florida Building Code Section 1507.3.4. ASTM C1167 covers physical and performance properties of clay tiles, including dimensions, weight and water permeability.

As of today's date Zion Tile has been unable to provide copies of these quarterly reports for clay tile shipments received in 2014, including a shipment received on 6/5/2014 and sampled for testing during the last Keystone Inspection on 6/19/2014.
