Welcome:

Time: 9:00 am

Mr. Peters welcomed everyone to the concurrent teleconference call of the Mechanical TAC and Structural TAC. She provided information for the callers on how to mute systems to avoid background noise.

Roll Call:

Mr. Peters performed roll call for the Mechanical TAC. A quorum was determined with 8 members present.

Agenda Approval:

Mr. Quintela entered a motion to approve the agenda for today's meeting as posted. Ms. Goll seconded the motion. The motion passed unanimously with a vote of 8 to 0.

Approval of the Minutes from March 30, 2016 and April 13, 2016

Mr. Calleja entered a motion to approve the minutes from the March 30, 2016 and April 13, 2016 meetings as posted. Mr. Quintela seconded the motion. The motion passed unanimously with a vote of 8 to 0.

Provide comments to the Rule Development Workshop "Rule 61G20-1.001, F.A.C." of June 8, 2016 for the purpose of reviewing proposed code language for the implementation of [HB 535: Proposed Code Changes](#)

Section 23(4): Provides for an indefinite extension of an exception to the requirements that mechanical equipment comply with the wind design requirements of the FBC.

Mr. Madani provided background information on section 23(4).with staff proposal.

Discussion was held regarding the language and placement for this section among the TAC members.

Mr. Calleja entered a motion to accept staff proposal with exception added to 1620.6 and not delete but add to exception stating legislative language. Mr. Pittman seconded the motion.

Ms. Peters performed a roll call vote. The motion passed with a vote of 7 in favor and Mr. Quintela voting against.

Public comments were heard and discussed.

Provide comments to the Rule Development Workshop “Rule 61G20-1.001, F.A.C.” of June 8, 2016 for the purpose of reviewing proposed code language for the implementation of HB 535:

Section 25: Provides for revisions of the standards for air infiltration testing and mechanical ventilation of residences and delaying the effective date of the blower door testing until July 1, 2017.

Mr. Madani provided background information on section 25 with staff proposal.

There was in depth discussion among the TAC members and the public regarding the dates and placements within this addition.

Gary Griffin entered a motion to accept staff recommendation adding effective date that speaks to mechanical ventilation for enforcement and 401.2 matches with the blower door effective date. Ms. Goll seconded the motion.

Discussion followed on intent and the legislative mandate.

Mr. G. Griffin withdrew his motion. Ms. Goll seconded the withdrawal of the motion.

Mr. G. Griffin entered a motion to accept staff recommendation. Mr. Pittman seconded the motion.

Ms. Peters performed a roll call vote. The motion passed with a vote of 7 in favor and Mr. Calleja voting against.

There being no further agenda items to be addressed the meeting was adjourned at 10:24 am.
