#### **TAC Comments:**

Commissioner Worrall advised of the following concerns regarding the report:

- 1. Skewed survey participation, mostly with low level disabilities and developmental disabilities along with care givers responses. She advised she sent 19 areas to contact that stated they would participate.
- 2. Interviewers did not question adjustable bed frames.
- 3. Other resources could have been used that are very near UF, such as Shands, Outpatient centers, VA Hospital, Independent Living Centers and the campus of UF
- 4. Limitations should have been noted for more in-depth interviews.

Ms. Mignardi stated she agreed with Dr. Worrall that these were generic key points that were take a ways as sampling was small.

Commissioner Worrall stated descriptions should be quantified.

Mr. Madani stated there was a scope of study set along with the questions to be asked, both reviewed by the TAC and voted on.

Mr. Leibovitz responded stating that he realized the sampling was less than ideal, there were many e-mails sent and calls made to the contacts that were provided with little to no responses. In addition he stated in using UF there would be HIPPA issues that could affect the research at UF if used. Mr. Leibovitz also stated due to low budget on the research they were very limited.

Commissioner Worrall stated she was hearing a lot of excuses which made her wonder if this was the correct group chosen to do this study. She further stated she would only accept this report if the following:

- 1. Add some of the limitations of the study and the fact that it was a small study
- 2. More in depth interviews were used instead of trying to secure quantifiable data
- 3. Outcome that adjustable bed height frames was one of the take a ways.
