


Dear Mr. Patrick:

The City has consulted with Mary Catherine Smith, Department of Community Affairs, concerning the application of Section 553.503, Florida Statutes as it applies to the 2010 Florida Accessibility Code and the requirements for compliance at 161 N. Atlantic Ave, Extreme Pool Challenge. It was recommended that the applicant, Gary Patrick, be denied exemption, on the City level, for requirements of Florida Statute 553, but may file for waiver per Florida Statute 553.512.

It is the Building Officials decision to deny recommendation of Business Tax receipt until a waiver of ADA Accessibility can be presented from the State.
