STATEMENT OF TELECONFERENCE PARTICIPATION PROCESS

Jeff Blair reviewed the teleconference participation process with participants reminding them that it is important to keep their phones on mute to minimize background noise, not to put their phones on hold, and to wait until invited to speak to avoid confusion and chaos. Jeff emphasized that all participants will have ample time to speak on all substantive agenda items. Participants were reminded to state their names each time they speak.

The Commission voted unanimously, 20 - 0 in favor, to approve the agenda for the June 27, 2017 teleconference meeting as presented/posted. Following are the key agenda items approved for consideration:

MEETING SUMMARY AND OVERVIEW

At the June 27, 2017 Teleconference Commission meeting the Commission received an update on the status of implementing the HB 1021 Supplement; and, a review of the proposed list of prices for the 6th Edition (2017) Florida Building Code from the ICC. Specific actions included voting unanimously: to accept the Final Report titled: "Survey and Investigation of Buildings Damaged by Category III Hurricanes in FY 2016-17—Hurricane Mathew 2016."

UPDATE ON HB 1021 SUPPLEMENT

Chairman Browdy noted that the 2017 Legislature passed HB 1021 requiring the Commission to amend the 6th Edition (2017) Florida Building Code to incorporate specific provisions regarding: eliminating the requirement for a door self-closing device pursuant to R302.5.1; substitution of door components pursuant to R609.10; and, mechanical systems and service water-heating systems commissioning and completion requirements, plan and reporting pursuant to C408.2, C408.2.1, and C408.2.4 respectively, and the Supplement will incorporate these Code changes into the 6th Edition (2017) Florida Building Code. The Chair indicated that the HB 1021 Supplement was linked to the June 27, 2017 FBC Agenda on the BCIS.

Tom Campbell provided the Commission with an update on the status of the HB 1021 Supplement noting the Governor signed the Bill on June 23, 2017 and that the provisions will become effective on July 1, 2017. Tom indicated that the action the Commission took on May 12, 2017 adopting the Supplement implements the Code provisions into the 6th Edition (2017) Florida Building Code pursuant to HB 1021. Tom noted that in addition the provisions would become effective for the 5th Edition (2014) Florida Building Code on July 1, 2017. Tom indicated that at the June 13, 2017 meeting the Commission voted to authorize the Department of Business and Professional Regulation to initiate a separate rule development process as Rule 61G20-1.005, Legislative Amendments to the Florida Building Code to incorporate these provisions into the 5th Edition, and staff will have the proposed language for the Commission's consideration at the August 2017 meeting.

PROPOSED LIST OF PRICES FOR THE 6TH EDITION FLORIDA BUILDING CODE (2017)

The Chair stated that with each update to the Florida Building Code the ICC, the organization that publishes the Code, proposes a price schedule for the sale of the updated Code. The Code is available in individual volumes and in combination collections. The Chair noted that the pricing schedule was linked to the July 27, 2017 FBC Agenda on the BCIS. Mark Johnson from the ICC was present on the call; however, there were no questions or public comment on the issue.

ACCEPTANCE OF FINAL REPORT INVESTIGATING HURRICANE MATHEW'S DAMAGE TO BUILDINGS

Chairman Browdy indicated that the Department has an annual contract with UF to investigate storm damage in the event a Category III hurricane impacts Florida (Titled: "Survey and Investigation of Buildings Damaged by Category III Hurricanes"). The Chair noted that as reported at the October 2016 meeting, UF deployed their Building Codes Triage Team to investigate and collect buildings damage data from the impacts of Hurricane Matthew, and that the focus of the

investigations was primarily for residential construction. At the October 2016 meeting the Commission expressed support for UF conducting follow-up research from the impacts of Hurricane Matthew, and DBPR staff contracted with UF to follow-up as requested. At the May 12, 2017 Teleconference meeting the Commission voted unanimously to accept UF's Interim Report titled: "Survey and Investigation of Buildings Damaged by Category III Hurricanes in FY 2016-17—Hurricane Mathew 2016."

The Chair invited Dr. David Prevatt and Dr. David Roueche from UF to provide the Commission with an overview of the Final Report and answer Commissioner questions. The UF principal investigators provided a presentation summarizing the results.

Following is a summary of the conclusions of the Report:

- Building code changes improved housing performance as follows:
 - 1. No sheathing or other structural damage observed in post-1992 homes.
 - 2. Pre-1992 buildings 2 times more likely to be damaged than 1992-2001 buildings.
 - 3. Pre-1992 buildings 3 times more likely to be damaged than post-2001 FBC buildings.
- Some types of damage common even in 60% of design event:
 - 1. Roof cover/soffit failure.
 - 2. Interior damage from wind-driven rain, rainwater intrusion.
- Homeowners are willing to pay <\$20,000 to avoid future damage.
- Homeowners are likely to evacuate.
- Homeowners in newer homes have better knowledge of the impact of building codes in protecting their home from damage.
- Flood damage can be investigated through the survey technique used in 2017.

Chairman Browdy remarked that the results of UF's investigations demonstrate that the Florida Building Code's provisions are succeeding as intended in reducing damage to buildings from storm and hurricane generated wind and water intrusion. The Chair noted that the Commission does not have a public relations consultant, and that it is up to industry stakeholders/advocates to educate the public regarding the efficacy of the Florida Building Code.

Following an opportunity for questions and answers, public comment and discussion, the Commission took the following action:

Commission Actions:

MOTION—The Commission voted unanimously, 22 – 0 in favor, to accept the Final Report titled: "Survey and Investigation of Buildings Damaged by Category III Hurricanes in FY 2016-17—Hurricane Mathew 2016."

Mo Madani (DBPR): requested clarification regarding whether the Commission's acceptance of UF's Report also included approval for DBPR to adjust the scope for the FY 2017-18 contract with UF for the "Survey and Investigation of Buildings Damaged by Category III Hurricanes" to include surveying of flood damage. Chairman Browdy indicated that unless a Commissioner disagreed (none indicated disagreement), that DBPR has Commission acceptance to add surveying of flood damage from Category III Hurricanes to the scope.

GENERAL PUBLIC COMMENT

Members of the public were offered an opportunity to provide comment during each of the Commission's substantive discussion agenda items. In addition, Chairman Browdy invited members of the public to address the Commission on any issues under the Commission's purview.

There were no general public comments offered.

COMMISSION MEMBER COMMENTS AND ISSUES

Chairman Browdy invited Commission members to offer any general comments to the Commission.

Commission Member Comments:

Brad Schiffer: stated that it would be beneficial if the BCIS could provide enhanced free public access to the 2017 Florida Building Code.

Tom Campbell (DBPR): responded that DBPR is in discussions with ICC on this issue, and assuming the price is affordable, the plan is to implement enhanced public access to the Florida Building Code on the BCIS.

Steve Bassett: indicated that the ICC should offer a discounted price for the purchase of the Code in both electronic and hard copy formats.

Mark Johnson (ICC): responded that he believed the ICC could provide a discounted pricing structure for the purchase of a combination of electronic (pdf downloads) and hard copy code volumes, and he would pursue this with ICC.

NEXT STEPS

Tom Campbell noted that the hotel link for the Commission's August 8, 2017 meeting is operational, and hotel reservations can be made online. Tom also noted that the Commission's TAC chairs will meet on August 7, 2017 at 1:00 PM to conduct the annual review of research projects proposed for Commission funding for fiscal year 2017-2018. The Commission will consider the TAC chairs' recommendations during the August 8, 2017 Plenary Session.

ADJOURN

The Chair thanked Commission members, staff and the public for their participation, and following a second role call confirming a quorum (22 members were present), and after a vote of 22-0 for adjournment, the Chair adjourned the meeting at 3:01 PM on Tuesday, June 27, 2017.
