Mr. Campbell then cited (2)(B) commercial and advised that this section does have a mandate listed by the Department of Energy. He then discussed the second handout which listed the standards posted on February 27, 2018 and the requirements of the Commission. Mr. Campbell stated this TAC is the first step in getting certification to DOE on the updates to the building code.

Discussion followed with Mr. Campbell responding.

Mr. Blair went over all of the criteria choices for recommending a code.

Mr. Madani provided an overview of the tracking and code charts for the TAC.
