There was further discussion among the TAC which included the possible need for a code change.

Mr. Lavrich, Commissioner Swope, Mr. Rodriguez, and Mr. Zehnal expressed concerns on the data within this report and the assumptions used to reach the specific changes in costs that were listed.

Mr. Silvers, FRSA provided additional comments regarding history of this code.
