6430 A-4 (cont.):

Mr. Schock advised he had other attachments that were not submitted with the original alternate language materials but was sent to Mr. Madani; however, he understood Mr. Madani could not share this information due to Sunshine Law.

Ms. Hammonds clarified that adding materials received after the 45 day period would require pulling modification from the consent agenda and be placed before the Commission in August.

Mr. Schock addressed Mr. Stafford's comments as a rebuttal.

6430 A-1

Andrew Lovenstein proponent was not present on the call. Mr. Schock expressed concerns on language "discretion of the building official".

Mr. Stafford stated he agreed with Mr. Schock on the language and stated again he felt a workgroup was needed.

Mr. Belcher stated he is same opposition as A-4.

Mr. O'Connor entered a motion for straw poll in support of A-4. The motion died due to lack of second.

Mr. Goff entered a motion for a straw poll not to support A-4. Mr. Boyer seconded the motion. The motion passed with a vote of 7 to 1.

Mr. Boyer entered a motion for a straw poll not to support A-1. Mr. Brown seconded the motion. The motion passed unanimously with a vote of 8 to 0.

Mr. Carlson entered a motion for a straw poll to support comment G-3. Mr. Goff seconded the motion. Mr. Blair performed a roll call vote and the motion passed with a vote of 6 to 2.
