### **Accessibility Waivers:**

Hell 'N Blazes Brewing Company – Waiver 314 - 1002 East New Haven Avenue, Melbourne 32901 - Issue: Vertical accessibility to the 30" lower level on the second floor:

BENGAL PROPERTIES, INC d/b/a The Park Apartments – Waiver 323, 11110 56th St, Temple Terrace 33617 - Issue: Vertical accessibility to the second floor.
