Location of Generator is not in compliance with FBC. Permits are not in compliance with minimum manufacturer's installation location ("It is important that the generator is not subject to water intrusion"...."find a stable area that is well drained and does not flood" (A drainage easement is by definition subject to flood water). Per Generac, nothing within 3 feet of both sides and front and not located within 3 feet of AC units. Also must comply with Florida Constitution and Florida Statute 877.03. The Village was given first written notice of multiple failures to comply with minimum requirements in December 2018.
