RE: Petition for Declaratory Statement on Application of Florida Residential Code in Areas of State where Wind Speed is 100 mph or Greater

Dear Mo:

We need a clarification from the Building Commission with regard to the applicability of Chapter 9 of the Residential Code to areas of the state where the wind speed exceeds 100 mph. As you are aware, there is a conflict in the valley metal width requirements of Chapter 9 FRC and Chapter 15 FBC. R905.2.8.2.1 requires metal valley to be at least 24 inches in width. 1507.2.9.2.1 of the FBC Building Volume requires the valley to be at least 16 inches wide.

Several FRSA members, in areas of the state where the wind speed exceeds 100 mph, have failed inspections on residential re-roofs because they did not use 24 inch valley metal. Others have been informed that they must follow the FRC on all residential construction and use 24 inch valley metal.

It is our understanding that Chapter 9 FRC, as well as several other FRC Chapters, are not currently for use in areas where the wind speed is 100 mph or greater, and that roofing contractors should rely on the provisions in the FBC Building Volume. We also understand that, as per Section R301.1.3, design in accordance with the FBC Building Volume is an acceptable alternative as long as the whole building is designed and constructed in accordance to either code, without mixing and matching.

We have provided this information to many of our members.

We would very much appreciate a declaratory statement from the Building Commission regarding this.
