I. OVERVIEW OF COMMISSION'S KEY DECISIONS

Monday, April 10, 2000

Rulemaking Hearing for Building Code Rule

The Commission held their second rulemaking hearing on the Building Code Rule. In addition, the Chair informed the Commission that they would be required to reconsider previously approved modifications to the base code, with the addition of a fiscal impact statement from the proponent of the modification, if they received any specific comment on those modifications. In light of this new statutory requirement, the Commission unanimously approved extending the comment period for the Building Code Rule until close of business on Friday, May 19, 2000 (Browdy/Wiggins). The Commission agreed to hold a rule development workshop for establishing the criteria for the fiscal impact statement in June, and to develop, adopt, and move to proceed with rule adoption of the criteria at the June Commission meeting.

Agenda Review and Approval of April's Minutes

The Commission reviewed and unanimously approved the agenda as presented and the minutes from the April 2000 Commission meeting.

Overview/Report of Key Issues and Direction from Legislative Session

The Chair informed the Commission that the Building Code Bill was approved by the Florida Legislature on Friday, May 5, 2000. In addition, the Chair and staff reviewed with the Commission key decisions and statutory changes as well as topical areas where Legislative direction varies from the Commission's recommendations. (A detailed report is included as Attachment 2)

Commission Recommendations to Governor on Signing Building Code Bill

The Commission discussed whether or not they as a body wished to recommend that the Governor sign the Building Code Bill into law. After discussion, it was moved and adopted by a vote of 16 – 1 in favor, that the Commission recommend their support for Governor Bush to sign the Building Code Bill (Lipka/Bassett).

The Commission expressed the desire that legal staff indicate in their analysis of the bill, the difference between the Commission's recommendations and the Legislature's approved definition of the wind-borne debris region. They requested that staff include a copy of both the Commission's and the Legislature's wind-borne debris region maps in order to graphically depict the differences between the two versions.

Overview of Economic Impact Criteria for Amending the Code

Legislative mandate requires that the Commission shall consider all future modifications as well as previously adopted modifications to the base code that receive specific public comment, in light of a fiscal impact statement from the modification's proponent. In addition, the statute requires the Commission to adopt the criteria for the fiscal impact statement by administrative rule. The Commission has agreed to hold a rule development workshop in June and a rulemaking hearing in July.

Following is the language in HB 291 approved by the Florida Legislature:

Section 109

The commission shall apply the criteria set forth at section 553.73(7)(a) and (1) (b), Florida Statutes, as amended by section 40 of chapter 98-287, Laws of Florida, and section 553.73(6)(c), Florida Statutes, as created by this act, for the adoption of any amendments to the base codes after the effective dates of this act. The commission shall review modifications to the base codes adopted by the commission on or before February 15, 2000, which are identified verbally or in writing during the public hearings on proposed rule 9B-3.047 held pursuant to chapter 120, Florida Statutes, except those integrating state agency construction regulations, high velocity hurricane zone provisions, and those necessary to harmonize the Florida Building Code with the Florida Fire Prevention Code, and shall confirm that such amendments meet the requirements of s. 553.73(7), Florida Statutes, as amended by s. 40, chapter 98-287, Laws of Florida. In addition, the commission shall apply the above referenced criteria to s. 610.1ABC.3.5.2 of chapter 13 of the Florida Building Code. Any modification which, after such criteria are applied is not approved for inclusion by an affirmative vote of three-fourths of the commission members present and voting, must be removed from the code pursuant to chapter 120, Florida Statutes.

Commissioner Parrino presented the Ad Hoc's report and recommendations, and the Commission unanimously approved the report and recommendations by a vote of 19 - 0 in favor.

Commissioner Mehltretter requested that the Commission take up the Threshold Inspector applications at June's meeting since the Committee is recommending approval for both applicants.

Update and Status Report on Copyright/Royalty Issues

Staff attorney Suzanne Schmith, presented the Commission with a letter from copyright consultant attorney, Ava Doppelt. The letter detailed out a series of questions that require Commission response. Chairman Rodriguez informed the Commission that he is appointing a Code Dissemination Ad Hoc Committee to review the questions, propose a timeline for completing the task, and advising the Commission on future direction relative to this issue. In addition, the Commission directed staff to inform Ava Doppelt that they did not want her to take any further action pending Commission review of the issue. Following are the questions identified for Commission consideration:

- How will the code be manufactured and sold?
- Will the SBCCI handle all manufacturing and fulfillment from Birmingham with the State simply transmitting orders it receives?
- If so, how will the State be compensated?
- If the SBCCI handles all order fulfillment, will it also furnish the other associated codes as well?
- Will the codes be made available on CD-ROM?
- Will the codes or any parts of the code be made available online, perhaps by subscription?
- And of course, how will the payment flow?
- Will the State pay any royalty? Will there be a flat license fee?
- Will the SBCCI be compensated simply for its profits on sales of the code?

Appoint Ad Hoc Committee

Chairman Rodriguez appointed the following Commissioners to serve on the Code Dissemination Ad Hoc:

George Wiggins (chair), Steve Bassett, Dick Browdy, Med Kopczynski, and Frank Quintana.

The Code Dissemination Ad Hoc is charged with reviewing and making recommendations on the questions, proposing a timeline for completing their task, and advising the Commission on future direction relative to this issue.

Review and Refine Workplan Relative to Legislative Mandates

The Commission reviewed a modified workplan and agreed to support the plan in concept pending formal review and approval at June's meeting. Jeff Blair reviewed the key elements of the modified workplan which reflected direction from Chairman Rodriquez and incorporated statutory mandates.

The Commission expressed their support for holding two day Commission meetings with Ad Hoc meetings on Monday and Commission plenary sessions on Tuesday. They also agreed that each Ad Hoc would meet every other month unless a critical path delivery schedule required monthly meetings for a specific Ad Hoc.

Finally, the Commission took a straw poll and voted 17 – 2 in favor of extending the Product Approval system delivery deadline to January 2001. However, they agreed to pursue resolution on this issue in as expeditious manner as possible and to start work on the system in June.

Product Approval System Review

The Commission took a straw poll and voted 17 – 2 in favor of extending the Product Approval system delivery deadline to January 2001. However, they agreed to pursue resolution on this issue in as expeditious manner as possible and to start work on the system in June.

Following is the language in HB 291 approved by the Florida Legislature:

Section 90. Subsection (1) of section 553.842, Florida Statutes, is amended to read:

553.842 Product evaluation and approval. --

(1) The commission <u>shall make recommendations to the President of the Senate and</u> <u>the Speaker of the House of Representatives prior to 2001 Regular Session</u> may adopt rules <u>pursuant to ss. 120.536(1) and 120.54</u> to develop and implement a product evaluation and approval system to operate in coordination with the Florida Building Code. The product evaluation and approval system shall provide:

(a)Appropriate promotion of innovation and new technologies.

- (b) Processing submittals of products from manufactures in a timely manner.
- (c) Independent, third-party qualified and accredited testing and laboratory facilities.
- (d) An easily accessible product acceptance list to entities subject to the Florida Building Code.
- (e) Development of stringent but reasonable testing criteria based upon existing consensus standards, when available, for products.
- (f) Long-term approvals, where feasible.
- (g) Recall or revocation of product approval.
- (h) Cost-effectiveness.

For purposes of this section, an approved product evaluation entity is an entity that has been accredited by a nationally recognized independent evaluation authority or entity otherwise approved by the commission.

Report of Legislative Action

Fiscal Impact Statement Criteria

Statutorily Mandated Criteria for Amendments to the Florida Building Code

553.73 Florida Building Code.— 553.73 (7)(a)(b)

(7)(a) The commission may approve technical amendments to the Florida Building Code once each year for statewide application upon a finding that delaying the application of the amendment would be contrary to the health, safety, and welfare of the public or the amendment provides an economic advantage to the consumer and that the amendment:

1. Has a reasonable and substantial connection with the health, safety, and welfare of the general public.

2. Strengthens or improves the Florida Building Code, or in the case of innovation or new technology, will provide equivalent or better products or methods or systems of construction.

3. Does not discriminate against materials, products, methods, or systems of construction of demonstrated capabilities.

4. Does not degrade the effectiveness of the Florida Building Code.

Amendments approved under this paragraph shall be adopted by rule pursuant to ss. 120.536(1) and 120.54.

(b) A proposed amendment shall include a fiscal impact statement which documents the costs and benefits of the proposed amendment. Criteria for the fiscal impact statement shall be established by rule by the commission and shall include the impact to local government relative to enforcement, the impact to property and building owners, as well as to industry, relative to the cost of compliance.

The Committee heard two presentations:

Presentation from the Insurance Service Office regarding the Building Code Effectiveness Grading Schedule (BCEGS). The presenter explained the BCEGS scope, elements (administration, plan review, field inspection), and classifications.

Presentation from the Commission for Florida Law Enforcement Accreditation, Inc. The presenter explained the structure of the accreditation system, the standard procedure manual used in the accreditation process, the structure of the Accreditation Commission, the application process and the criteria for obtaining certification.

Develop outline for draft letters to invite stakeholders to participate in the system development. The Committee approved the draft letter and recommended to send the letter to BOAF, Miami - Dade / Broward, DOE, Fire service, Insurance industry, School of Construction,etc.

Develop outlines and format for the needs assessment.

The Committee established a list of specific criteria for a need assessment pertaining to permitting, plans review, inspection and construction completion.

At the next meeting, the Committee will address the following questions:

Are we establishing an accrediting entity? ; Why we establishing the system? and What is in it for local governments?

Proposed Workplan Modifications Reviewed by Commission
