#### I. OVERVIEW OF COMMISSION'S KEY DECISIONS

#### Monday, August 21, 2000

#### **Rule Making Hearing for Fiscal Impact Criteria**

The Commission conducted a hearing and received public comment on the proposed fiscal impact statement rule.

#### Hearing on Notice of Proposed Changes to Building Code Rule

The Commission conducted a hearing and received public comment on the proposed changes to the Building Code Rule. The Commission will review the public comment and testimony and decide whether or not to reconsider any proposed changes.

#### **Product Approval Ad Hoc**

The Product Approval Ad Hoc met and committee members reviewed, amended, and adopted the grandfathering subcommittee's recommendations as amended. In addition, the committee was asked to review the various comments under each of the key topical areas and to propose options to bridge any differences between the comments for consideration at September's meeting.

#### **Review and Approval of June 13, 2000 Meeting Minutes**

The Commission unanimously, by a vote of 18 - 0 in favor, adopted the minutes as amended from the July 10 - 11, 2000 Commission meeting.

#### **Review and Approval of Agenda**

The Commission reviewed and unanimously, by a vote of 18 – 0 in favor, approved the agenda as amended. The Commission voted in support of rescheduling Education workshop I in September in order to schedule presentations prior to their facilitated session to identify key issues and needed resources.

#### **Approval of Meeting Dates and Locations**

The Commission reviewed and unanimously, by a vote of 18 – 0 in favor, approved the proposed meeting dates and locations for the first six months of 2001 (January – June). Following are the approved dates and locations:

#### **Review and Approval of Commission's Workplan**

The Commission reviewed the workplan and task delivery schedule and voted unanimously, by a vote of 18 – 0 in favor, to adopt the workplan as presented.

#### **Consideration of Accessibility Waiver Applications**

The Commission reviewed and decided on the Waiver applications submitted for their consideration.

#### **Review of Commission's Budget**

Ila Jones, Codes and Standards administrator at DCA, presented the Commission with a report and overview of their annual budget for conducting business. (*Attachment 2*)

#### **Product Approval Ad Hoc Progress Report**

Commissioner Mehltretter presented the committee's report which included the ad hoc's recommendations on grandfathering. The Commission voted to amend the grandfathering recommendations to allow Broward county to utilize their current system for product approval during the approved grandfathering phase. The Commission unanimously approved the report and recommendations as amended by a vote of 17 - 0 in favor. Ad Hoc members were asked to review the key issues for resolution and to consider and be prepared to offer options to bridge differences between any differences recorded under each of the topical areas.

#### Manufactured/Prototype Buildings Ad Hoc Report and Recommendations

Commissioner Kopczynski presented the committee's report and final recommendations on the manufactured building program. After approving errata corrections submitted by Commissioner Calpini, the Commission unanimously approved the final recommendations on manufactured buildings as amended and moved to proceed with rule adoption, by a vote of 17 –0 in support. (Attachment 4)

#### **Code Dissemination Ad Hoc Report and Recommendations**

Commissioner Wiggins presented the committee's report and recommendations. The Ad Hoc recommended that Chairman Rodriguez, or his designee, enter into negotiations to finalize the copyright and royalty issues associated with the dissemination of the code. The Commission unanimously approved the report and recommendations by a vote of 17 - 0 in favor.

#### **Plumbing TAC Report and Recommendations**

Commissioner Shaw presented the committee's report and the Commission unanimously approved the report by a 17 – 0 vote in favor. In addition, the Commission was asked to approve several recommendations.

The Plumbing Ad Hoc will meet every other month in Orlando.

Errata omission in plumbing Code will be corrected. Approved 17 - 0.

Commission will take necessary action to ensure well contractors will be permitted to perform their historic tasks relative to wells. Approved 17 – 0.

The Plumbing TAC will review water heater safety devices with input from manufactures and deliver recommendation to the Commission. Approved 17 – 0.

#### **Education System—Legislative Mandates and Reporting Requirements**

Rick Dixon gave the Commission an overview of the importance of an education system component to the Florida Building Code for the long-term effectiveness and viability of the code. He explained that the Commission is required to report annually to the Legislature on the effectiveness of the code and that the Study Commission's findings indicated that education is the most effective method to ensure that the code is both enforced and complied with.

Jeff Blair explained that beginning in September the Commission will take up development of the education system beginning with targeted presentations and a facilitated session to identify key issues, existing resources, needed resources, and next steps. The Commission should complete their recommendations in time to submit them to the 2001 Legislature.

#### Legal Staff Reports/Discussions/Recommendations

Suzanne Schmith gave the Commission an update on the pending rule challenge to the Building Code Rule, and asked the Commission to authorize a closed session to discuss the challenge and possible settlement options at the September meeting. The Commission voted unanimously, by a vote of 17 – 0 in favor, to hold a closed session.

- The Commission voted unanimously, by a vote of 17 0 in favor, to appoint Bunny Armstrong and Warren Jernnigan to the Accessibility TAC.
- The Commission voted unanimously, by a vote of 17 0 in favor, to send proposed modification number 4PFC056 to the appropriate TAC for review and recommendations.

#### **Report on Grandfathering**

Product Approval system is to coincide with implementation date of Florida Building Code.

**Grandfathering definition:** Florida Building Commission shall establish and make available a list of product evaluations entities, testing labs, certification, listing, and Quality Assurance agencies deemed to be approved on the effective date of the Florida Building Code. A report by these entities or agencies showing compliance with current applicable code in Florida shall grandfather the report for period of two years, or for the expiration date of the report. If less than two years, then the report will be recognized up to the two year period.

In Miami-Dade County only products w/ Miami-Dade approval can be grandfathered in Miami- Dade County.

- Would product have to re-submit if product approval system changes.
- Does grandfathering prevent scrutiny for life of the certification
- Provide 2 year grace period for existing product approval currently in place.

What products eligible for GF

GF testing organizations, QA entities, and not the products (cert. Agencies)

consider all products in evaluation process and consider GF after Legis session.

Consider more time i.e. 2 years.

Consider implementation date.

Any products would have to meet the new code.

#### Minimum time frame of existing approval and how long QA

#### **Time limit**

1 year after implementation of code or the expiration date of the product which ever is last.

Include evaluations and validation, testing report in timeline

2 year period instead of 1 year.

\*\*2 year voted in, 2 years after implementation of code or the expiration date of the product whichever is last.

Expiration is 2 year after implementation of code.

#### **Product or entities**

Entities should be GF.

Coincide w/ entire PA system

Tom Kopec – prefer 2 years of expiration date

GF what flows from entity and not entity.

Allow local jurisdiction to approve during GF phase.

#### **Residency requirements to be considered.**

- \* For Manufactured Building remove requirement for Florida residency.
- \* Needs research for rationale on residency requirements.
- \* Committee consensus to research FS 633.

#### **Other considerations relative to Fire requirements:**

- \* Consider specialty inspectors for Mfg Bldg.
- \* Consider experience to qualify for certification testing.

 $^{\ast}\,$  Coordinate discussion between Fire Marshall and  $3^{\rm rd}$  party agencies and report preliminary findings at the October meeting.

- \* Look for a centralized entity (state agency) for education facilities?
- \* Communication with local BO relative to approved State plans-except siting.
- \* Consider minimum threshold requirements for different buildings (i.e. small offices).

It was noted that any "Grand-fathering" would require legislative change.

#### FS 633 Training requirements:

- \* 200 hour 5/40 hour for certification examination (State fire college) continuing education 40 hours every three years.
- \* Equivalent state training approved by Department for certification.

#### **Eligibility requirements:**

- High school diploma
- \* 18 years old
- \* **Resident Florida certification**
- \* The State Fire Marshall will maintain a list of certified Fire Officials or; utilize certified in house employees.

#### **Reporting Procedures:**

- Plans review, 3<sup>rd</sup> party agency to be 633 certified. Report to be kept in central entity.
- Interpretations by the State Fire Marshall.

#### **Out of State QC provisions:**

\* Meet Florida requirements.

#### **Required Fire inspections:**

- \* 50% at factory (before closing walls)
- \* 100% final at site by local BO (CO)

#### **Grand-fathering:**

- \* No provisions for certification currently exist,
- \* State Fire Marshall to promulgate rule

### **Plumbing/Gas TAC Report**

August 21, 2000

- I The TAC decided that it wants to keep meeting every other month.
- The TAC considered whether a licensed plumber is required to install well pumps and tanks and approved a motion to ask the commission to allow water well contractors to continue installing pumps and tanks.
- The irrigation subcommittee reported that they plan to have a revised draft irrigation code ready by the next meeting. They also have a licensure problem.
- The TAC moved that the pipe insulation criteria table, included in the notice of changes, be clarified to include residential in a separate column instead of as a footnote.
- Discussion of the grease interceptor issue concluded that the code is adequate as is and that other state and federal agencies are capable of monitoring maintenance.
- A new issue was raised of defective water heater dip tubes and their impact on pressure relief valves. The TAC approved a motion to ask the Commission to request that the industry look at the issue of clogged relief valves and report those results to the TAC at the next meeting.
- The TAC went over a list of major differences between the current plumbing codes and the new Florida plumbing code and prioritized those changes needing emphasis for code-change training. Representatives of the gas industry will submit a list of prioritized code change issues by the end of September.
