3) Proposed Electrical amendents to the "Glitch" cycle

#084 (Defer to Special Occupancy TACS for action) Section 427.1.4.13.3 Requires all electrical outlets must be ground fault circuit interrupter protected.

Committee action: Propose approval of 084/disagrees with staff analysis

Motion. TAC (disagrees) with staff recommendation and recommends to change in favor in favor of #084 a technical change. .Ed/Terry-Unanimous in favor of motion.

#188 Change to allow access to qualified individuals to disconnect power in case of emergencies without obstacles, also provides for the elimination of flammable materials. TAC agrees with staff, defer to 2003 base code change.
