SUBJECT: Petition for Declaratory Statement Before the Florida Building Commission

Dear Ms. Ford:

Please consider this letter as a request for a petition for a declaratory statement before the Florida Building Commission. We are interested in an interpretation relating to "garage door model/series number", one of the items required on a garage door label as provided for in FBC Building Volume section 1714.5.3.4 and in FBC Residential Volume section R613.4.5.

Specifically, we would like to ask the following question: Is "garage door product code" considered an acceptable equivalent to "garage door model/series number"?

A "product code" is used in the industry when multiple model/series numbers are used for the same product configuration off of the same production line. Different model/series numbers may be used for different brand names, where each brand name is targeted to a specific market. Different model/series numbers may also be used for different distribution channels (e.g. retail, regional distributor, direct-to-dealer). One garage door manufacturer has informed us that they may have up to 9 model/series numbers for the same product configuration; therefore, in this example, use of a "product code" would be more practical than listing nine different model/series numbers on a garage door label.

For manufacturers using "product code" on a garage door label, model/series numbers would be cross-referenced in Florida product approval related documents in order to comply with provisions in the applicable Florida Building Code Volumes.

Please advise as to when our Petition will be considered by the Commission. In the meantime, if you have any questions, please contact me. Thank you for your consideration of this matter.
