Mr. Clark stated that he did not have a good reason why this information was missing, except that it was overlooked by the accreditor.</i> <i>Commissioner John suggested that Mr. Clark, in his capacity as Education Administrator, supply all accreditors with a checklist of required information regarding future course submittals. Commissioners Bourre and Brown agreed with Commissioner John. Mr. Clark stated that he will indeed supply that list to accreditors.</i> Approved Unanimously</p> <p>Course: 2020 Advanced Florida Building Code Public & Private Swimming Pools 7th Edition Provider: American Society of Landscape Architects Florida Chapter Accreditor: Bill Dumbaugh BCIS Course Number: 1115.0 Motion: Course <i>conditionally approved</i> based on the FBC accreditation process that only verifies the accuracy of the Florida Building Code related content, <i>subject to the addition of the Certificate of Completion and the removal of the term “Draft” from the background of all of the PowerPoint slides.</i> Motion: Don Brown Second: Brad Schiffer Discussion: <i>The Education Administrator found that the Certificate of Completion was missing, and the term “Draft” should be removed from the background of all of the PowerPoint slides.</i> <i>Commissioner Brown asked Mr. Clark what the worse situation would be for providers between a course being denied or conditionally approved. Mr. Clark stated that if a course is denied by the ED POC, then it would have to be re-accredited, resubmitted to the ED POC, with out being taught or used in the interim. All of those steps would be costly to the provider. If a course is conditionally approved, then the provider can immediately fix whatever issue(s) were identified, then use the course</i></p>

	<p><i>without resubmitting. It was also suggested by a commissioner that if a course was not up to standard when it was submitted, that it should be taken off the agenda until it meets the rule requirements. Thomas Campbell stated that because of Chapter 120, submitted courses must be scrutinized by the FBC, or negative legal implications can arise for the FBC. Again, all commissioners were in agreement that a list of rule requirements should be given to all accreditors.</i></p> <p>Approved Unanimously</p>

Reimbursement amount: \$23.00 per hour per attendee Available now, ends June 15, 2023

Eligible attendees:

- Licensed architects, engineers, interior designers, landscape architects, construction contractors, electrical contractors, or building code administrators or inspectors
- Home inspectors, mold remediators
- Must include license number for all categories above
- Employees in design and construction industries, requires this documentation:
- Letter from their design/construction licensed employer
- Copy of certificate of workers’ compensation insurance or exemption
