- SB 648 Relating to Building Safety (Bennett) (building codes bill for 2010 session) moving
- HB 663 Relating to Building Safety (Aubuchon) (companion to SB 648 above) moving

SB 266 - Relating to Department of Community Affairs (Bennett) (shell bill)

SB 268 - Relating to Department of Community Affairs (Bennett) (shell bill)

SB 270 - Relating to Florida Building Code (Bennett) (shell bill)

SB 272 - Relating to Florida Building Code (Bennett) (shell bill)

SB 846 / HB 7095 - Relating to Fire Sprinklers (Bennett)(Schenck/House Governmental Affairs)

SB 2694 - Relating to Florida Building Commission (Constantine)

SB 648 and HB 663 are moving along and this legislation should pass this session. SB 266-272 are "shell" bills meaning they do not contain anything – they simply express legislative intent to change the law on the subject as specified – no action on these. These bills are placeholders and may not even be used. If scheduled for hearing, substantive legislation will be amended onto the bill at its first committee hearing. SB 2694 contains some provisions (same or similar) to provisions in HB 663/SB 648.

F. Pending issue on whether accreditation and subsequent approval process of current Accessibility course is an issue for legal counsel or can be done procedurally by Education POC – will research next month (after conclusion of legislative session).
