# TAC Comments (cont.):

Mr. Holland stated he had some suggested clarifications in certain areas. He stated on page 312 under 110.26 (c)(2), where it indicates a cost increase associated with large equipment, he stated this does not change the electrical installation costs, however it should be shared with the Structural TAC.

Mr. Holland addressed page 314, 2108.B though 2108.E and the verbiage addressing the \$15.00 per receptacle costs as needing clarification as it is not per receptacle but for protection of the receptables in the space.

Mr. Holland continued with page 319, 230.62 (c), stating this is not new language for barriers and has just been relocated. Additionally, he said that 230.71 is not a new requirement but rather is now an option.

Mr. Holland stated on page 320, 230.85 under the new requirement it only changes the design equipment and the max that should be paid would be \$475.00, should they elect to use this design.

Dr. Issa stated he will review all of the comments and recommendations and in addition the entire report will go under another full review.
