**NEW COURSES...April 2024 ED POC Meeting**

**1.) Course Number 1259.0...**

**Course:** Florida 2 – Hour Advanced Code Module 2023 FBC (2020 NEC) - Internet

**Provider:** Mike Holt Enterprises of Leesburg, Inc.

**Accreditor:** Charles Barr

**Accreditation date:** 3/14/2024

This is a 2-hour online course that covers electrical rules for the 2023 Florida Building Code contained in the 2020 NEC for Branch-Circuit, Feeder, and Service Calculations, Services, and Overvoltage Protection. The objective of this course is to help the electrical contractor understand concepts in Articles 220, 230, and 242 that apply to various load calculations and the installation of service disconnects and surge protective devices in dwellings and commercial occupancies.

**2.) Course Number 1248.0...**

**Course:** Advanced Florida Building Code 8<sup>th</sup> Edition (2023) Covering The Most Significant Changes

This course is designed to cover the most significant changes from the 7th Edition to the 8th Edition of the Code, but not every change made between the two revisions of the Code.

- a. The course Outline and Timeline were missing
- b. The title page for the Presentation document was missing
- c. The font was smaller than 12 pt. in the Presentation document

**As a result, I recommend denial of this course because it does not meet the full requirements of Rule 61G20-6.002. However, the ED POC could motion to instead conditionally approve this course, subject to adding the course Outline and Timeline, adding a title page to the**

**Presentation document, and increasing the size of the font to 12 pt. in the Presentation document.**

### **3.) Course Number 1238.0....**

**Course:** 1 Hr. Florida Building Code Mechanical 8<sup>th</sup> Edition (2023) Advanced Internet Course

**Provider:** 1<sup>st</sup> Choice CE

**Accreditor:** JC Code & Construction Consultants, Inc.

**Accreditation date:** 2/29/2024

This is a 1-hour online course that will cover the general requirements for the installation, repair and maintenance of appliances and equipment in various locations and environments.

Whether a contractor will be installing equipment in a garage or a condensate disposal piping system, this course will give them a basic understanding of what standards must be followed.

*As a result of an administrative review of this course, I found no issues and recommend approval.*

#### **6.) Course Number 1229.0....**

**Course:** 2023 Florida Building Codes: 8<sup>th</sup> Edition Updates Advanced Code Class

**Provider:** Building Officials Association of Florida

**Accreditor:** Contractors Institute (Koning Enterprises, Inc.)

**Accreditation date:** 3/18/2024

This is a 2-hour instructor-led course that will provide an overview of the building codes currently in effect in Florida, their navigation, their governance, and their relationship to the international codes. This presentation will then focus on changes and provisions new to the 8th edition of Florida's suite of Building Codes that relate to the design of structures. Discussion will also include anticipated impacts of these changes from an implementation and design perspective.

**Note:** *The course accreditation/submission deadline was March 24th, 2024. When this course ( # 1229.0) was reviewed by the Education Administrator (EA) on March 25<sup>th</sup>, he found that the Powerpoint presentation had been uploaded twice, meaning that the Syllabus was missing. With no Syllabus, that meant no Course Description, Learning Objectives, Outline/Timeline, Evaluation, Method of Presentation, provider contact information, and Certificate of Completion. The EA called the accreditor to let her know of his discovery of the missing Syllabus. She stated that a mistake had been made by the provider, when uploading some modified material, and the Syllabus was excluded. She further stated that this mistake was not caught by the accreditor.*

*The EA, Mo Madani, and Justin Vogel discussed this situation and concluded that the missing Syllabus could be uploaded into the BCIS, so the reviewing commissioners could check the quality of the Syllabus, even though it was added after the course submission deadline. The EA reviewed the Syllabus and found that it was complete and thorough.*

**Given this explanation and after an administrative review of this course, it was found that...**

- a. The Course Description, Learning Objectives, Outline/Timeline, Evaluation, Method of Presentation, provider contact information, and Certificate of Completion was missing as a result of an upload mistake by both the provider and accreditor. This information, as stated in the above explanation, has now been correctly provided
- b. The title page for the Powerpoint was missing

**As a result, I recommend denial of this course because it does not meet the full requirements of Rule 61G20-6.002. However, the ED POC could motion to instead conditionally approve this course, subject to verifying the missing information in the Syllabus, and adding a title page to the PowerPoint.**
