Discussion: Commissioner John stated that he could not find valid references to the Florida Building Code on some of the PowerPoint slides (for example slides 15, 20, 21, 22, 23).

Tim Tolbert (training provider) stated that the slides Commissioner John was noting were based on the BOAF Model Code, which was based on the Florida Building Code. He further said that most communities in the state will use the BOAF Model Code and tweak it for their use.

Commissioner Schock stated that Chapter One of the BOAF Model Code is written so communities can indeed tweak and adopt for local use. He further said he saw no problem with using the BOAF Model Code.

Commissioner John stated that the explanation given by Mr. Tolbert may be true, but the way the slides read is very confusing. Mr. Tolbert stated that slide two explains what he did, using the Chapter One BOAF Model. However, that slide is located on an earlier version of PowerPoint, not this latest version.

Justin Vogel (FBC legal counsel) stated that because the explanation of using the Chapter One BOAF Model was located in an earlier version of the PowerPoint, consequently the ED POC has not had the opportunity to review the correct version of the materials.

Commissioner Schock asked Mr. Tolbert if he was attempting to have this course approved to be used at the June BOAF conference. Mr. Tolbert said that he only tried to move this course through the normal process. Mo Madani (DBPR) stated that 90% of the Chapter One BOAF Model Code is based on the Florida Building Code. He further stated that the remaining 10% should be highlighted and explained, which should take away any confusion.

Tim Tolbert stated that he also was unclear regarding exactly what a "change" to a course meant. For example, is deleting a slide a change. Mr. V ogel said yes, deleting a slide is a change. Commissioner John stated that he recommends that this course be denied and resubmitted as a new course.

Justin Vogel agreed, saying that the course, as is, should be denied because it is the incorrect version of PowerPoint.

Training Funding Available for 2024-2025

Two types of funding: 7-hour program or "minimum 1 hour" program Reimbursement amount: \$23.00 per hour per attendee Available now, ends June 15, 2025 Eligible attendees:

-- Licensed architects, engineers, interior designers, landscape architects, construction contractors, electrical

contractors, or building code administrators or inspectors

- -- Home inspectors, mold remediators
- --- Must include license number for all categories above
- -- Employees in design and construction industries, requires this documentation:
- --- Letter from their design/construction licensed employer
- --- Copy of certificate of workers' compensation insurance or exemption

Eligible course topics:

- -- Florida Building Code
- -- Florida Fire Prevention Code
- -- Construction plan and permitting requirements
- -- Construction liens
- -- Hurricane mitigation

For "minimum 1 hour" program, course requirements:

-- At least 50% must be codes

For 7-hour program, course requirements:

- -- At least three (3) hours codes
- -- At least two (2) hours advanced codes

For any program, course requirements:

- -- Mitigation training for home inspectors must include proctored exam and comply with section 627.711(2), F.S.
- -- *Course evaluations are REQUIRED that cover the following:
- --- Satisfaction with instructor
- --- Satisfaction with course materials
- --- Satisfaction with conduct of the training
- --- Ask whether "highly satisfied" "satisfied" "not satisfied" for each above

Must enter into an agreement before submitting for grant funds, must verify availability of funds first.

Documentation required (failure to submit is a 5% penalty):

- -- Submitted within FIVE (5) WORKING DAYS AFTER EACH COURSE
- -- Advertisement (must be approved in advance)
- -- Sign in sheets as acceptable for each licensing board
- -- Separate sign in sheets for licensees and non-licensed employees
- -- Non-licensed employee sign in sheets must include type of proof submitted
- -- *Copy of course evaluation for each attendee

*Failure to demonstrate that 75% or more of trainees were satisfied or highly satisfied with the course instructor will result in a 1% penalty for each 5% increment or portion thereof that the percentage of satisfied trainees fall below 75%.

OTHER POC BUSINESS

Mo Madani (DBPR) stated that the way the Education Rule is written (61G20-6.002), it says that a self – affirmed course with either no change or one change does not have to be reviewed by an accreditor. However, if more than one change, then the course must be reviewed by an accreditor. Currently, it is reviewed by the Education Administrator and placed on the agenda. If it has been determined that more than one change has occurred during the ED POC Meeting, then it could be denied or conditionally approved. Mr. Madani (DBPR) is proposing that from now on, when (during his review) the Education Administrator identified that more than one change has occurred with the materials, that he can (verified by the Rule language) reject the course (before it is placed on the agenda) and send it back to the provider to be reviewed by an accreditor.

Michael Clark (Education Administrator) stated that he will send out a notice to all accreditors and providers describing this latest explanation as to how self-affirmed courses will be treated.
