Roll Call:

Mr. Blair performed roll call for the Energy TAC. A quorum was determined with 10 members present at roll call.

Agenda Approval:

Mr. Cochell entered a motion to approve the agenda for today's meeting as posted. Mr Geyselaers seconded the motion. The motion passed unanimously with a vote of 10-0.

Approval of the minutes from December 2, 2021:

Mr. Cochell entered a motion to approve the minutes from December 2, 2021 as posted. Mr. Geyselaers seconded the motion. The motion passed unanimously with a vote of 10-0.

To review and provide recommendation to the Commission regarding proposed code changes to the 7th Edition (2020) Florida Building Code – Energy Conservation as proposed by staff pursuant to Section 553.73(8), Florida Statutes and necessary to update the energy minimum efficiency standards for certain products for consistency with the federal minimum energy efficiency standards as established by U.S. Code of Federal Regulation, 10 CFR Part 430 Subpart C, Section 430.32.

Mr. Madani briefly provided details on the recommendation to the Commission regarding proposed code changes to the 7^{th} Edition Florida Building Code.

Mr. Madani provided an answer to Mr. Decarion's question.

Motion:

Mr. Sanders entered a motion to recommend that the Commission adopt the draft code language pursuant to Section 553.73(8), F.S., to update the Florida Building Code, 7th Edition (2020), to include the U.S. Department of Energy's new HVAC efficiency requirements as proposed by DBPR staff, and to proceed with rulemaking for Rule 61G20-1.001 — Florida Building Code Adopted. Ms. Smith-Burk seconded the motion. The motion passed with a vote of 9-1.

Mr. Calleja entered a motion that DBPR staff seeks clarification from DOE regarding using existing equipment for permitted projects, equivalency tables between SEER and SEER2 tested equipment, and applicability of the provisions to equipment change-outs, and report the results back to the Commission. Mr. Sanders seconded the motion. The motion was passed unanimously with a vote of 10-0.
