#### Welcome:

Time: 10:00 a.m.

Mr. Blair welcomed everyone to the teleconference meeting of the Product Approval Program Oversight Committee.

### **Roll Call:**

Mr. Blair performed roll call for the Product Approval Program Oversight Committee. A quorum was determined with 3 members present at the time of roll call.

#### **Agenda Approval:**

Mr. Blair asked for a motion to approve the agenda for today if there were no changes.

Commissioner Compton entered a motion to approve the agenda as posted for today's meeting. Commissioner Swope seconded the motion. The motion passed unanimously with a vote of 3 to 0.

## **Approval of Minutes and Facilitation Report from May 27, 2021 meetings:**

Mr. Blair asked for a motion to approve the facilitator's report and meeting minutes from the May 27, 2021 meeting, if there were no changes.

Commissioner Compton entered a motion to approve the minutes and facilitator's report as posted from the May 27, 2021 meeting. Commissioner Swope seconded the motion. The motion passed unanimously with a vote of 3 to 0.

Dale Nelson, President of Roof Hugger Inc., requested that FL 32041-R5 to be removed from the consent agenda for individual consideration regarding lack of statement for failing to show the stated values of the mandatory safety factor of 2.

Mr. Madani addressed the comment and concerns presented by Mr. Nelson. He stated these comments have not been addressed as there were just received. He stated the Committee may wish to conditionally approve to allow applicant to provide clarification on the safety question presented by Mr. Nelson.
