THURSDAY, AUGUST 7, 2025

MEETING SUMMARY AND OVERVIEW

At the Thursday, August 7, 2025, web and teleconference-based virtual meeting, the POC considered regular procedural issues including product approval and entities statistics reports; a status report on conditional approvals from the June 10, 2025 Commission meeting indicating that all of the applications are now resolved and approved with the exception of FL 46130, FL 46616, and FL 47478; review and approval of product and entity applications; and a review of DBPR approved product approval applications. Specific actions included recommending the Commission: Take action on product and entity applications as recommended by the POC and reflected in DBPR staff's product and entity approval reports.

AGENDA ITEM OUTCOMES

1. A. STATEMENT OF TELECONFERENCE PARTICIPATION PROCESS

2. AGENDA REVIEW

The POC voted unanimously, 3 - 0 in favor, to approve the agenda for the August 7, 2025 meeting as posted/presented. Following are the key agenda items approved for consideration:

3. REVIEW AND APPROVAL OF THE MAY 29, 2025 MEETING MINUTES AND FACILITATOR'S SUMMARY REPORT

As a result of the Product Approval POC not achieving a quorum for the May 29, 2025 meeting, the entity and product approval applications were taken up directly by the Commission, and as a result there were no meeting minutes or Facilitator's Summary Report to approve.

4. A. REPORT ON CONDITIONAL APPROVALS FROM THE APRIL 15, 2025 MEETING

Rodney Hershberger reported that all of the relevant conditions were met for each of the conditional approvals reported at the April 15, 2025 Commission meeting, with the exception of FL 46130, FL 46616, and FL 47478. Mo Madani reported that for each of these products approval is contingent on the manufacturer revising the applications per the conditions for approval. Mo indicated that for FL 46130 the manufacturer is working with Miami-Dade County on the required NOA, for FL 46616 the manufacturer is working to resolve the QA issue potentially seeking a new QA entity, and for FL 47478 the manufacturer is still working on the application and the product approval applications is listed as "applied for."

4. B. PRODUCT APPROVAL AND ENTITIES STATISTICS REPORT

Rodney Hershberger requested that staff review the statistics reports. Melissa Campos reviewed the product and entities statistics reports with participants, and answered members' questions. Melissa reported that the total number of product approval applications approved to the 2023 Code is 7,177 (7,921 total in the System), the total number of products approved to the 2023 Code is 29,135 (31,710 total in the System), and the total number of entities approved to the 2023 Code is 133 (454 total in the System).

The statistics reports are linked to the Product Approval POC agenda.

5. A. ENTITY APPLICATIONS CONSENT AGENDA

ENTITY APPLICATIONS FOR APPROVAL TO THE 2023 CODE

Jeff Blair presented the consent agenda of entities recommended for approval to the 2023 by asking if any participant or POC members wished to have any entity applications pulled from the consent agenda for individual consideration. There were no entity applications pulled for individual consideration.

POC Action:

MOTION – The POC voted unanimously, 3 - 0 in favor, to recommend the Commission approve the consent agenda of products (168*) recommended for approval to the 2023 Code as amended.

*FL 47587 was pulled from the Consent Agenda for individual consideration at the request of the applicant.

Jeff Blair reported that FL 47587 was pulled from the Consent Agenda for individual consideration and recommended for conditional approval at the request of the Applicant.

MOTION – The POC voted unanimously, 3 - 0 in favor, to recommend the Commission conditionally approve product FL 47587 to allow the applicant to correct the installation drawings for .2, .3 and .4 so they are in sequence with the subsection numbers.
