<u>The structure being constructed is called "BAHAY KUBO"</u>, which is a replica of a <u>Philippine Heritage Home. It is a thatched hut with bamboo exterior wall finish. The purpose</u> is to be used as a model to show the second generation Filipinos and the general public the type of houses they had in the Philippines. It is a single story building, 636 square feet in size. The structure itself is constructed in accordance with the Florida Building Code with the Building Permit issued by Hillsborough County. The exterior is finished with bamboos and synthetic thatch to give it the "Bahay Kubo" appearance.

5. Project Construction Cost (Provide cost for new construction, the addition or the alteration):

<u>The total project cost is approximately \$75,000.00 which includes all materials and</u> labor for constructing the structure, finishing, landscaping and site preparation. The estimated cost for the "HANDICAPPED RAMP" itself is \$10,000.00 (please refer to the attached construction estimates.

8. **Reason(s) for Waiver Request:** The Florida Building Commission may grant waivers of Florida-specific accessibility requirements upon a determination of unnecessary, unreasonable or extreme hardship. [X] The hardship is caused by a condition or set of conditions affecting the owner which does not affect owners in general.

<u>The requirements of the Florida Building Code for ingress and egress for a new public</u> or commercial building does not apply in this case. The building (Bahay Kubo) is not intended to be occupied. It is only a display and the displayed features are on the outside finish and design of the structure. People do not need to go inside to appreciate it. As shown in some of the attached pictures, we are in the process of installing exterior bamboo finishing on the exterior walls and thatch on the roof.

<u>The Philippine Cultural Foundation, Inc. (PCFI) owns a 10-acre property at 14301</u> <u>Nine Eagles Drive, Tampa, Florida. Every year PCFI holds a Cultural Festival Event open to</u> <u>the public. In this event, it showcases Philippine art, music, folk dances, foods, costumes, etc.</u> <u>The Bahay Kubo will be an added feature of the Philippine Culture. It is a replica of a</u> <u>Philippine Heritage Home.</u>

[X] Substantial financial costs will be incurred by the owner if the waiver is denied.

<u>The owner (Philippine Cultural Foundation, Inc.) is a not for profit organization</u> <u>under 501(c)(3) and it raises its funds through various fund raising events. The cost of</u> <u>constructing the ramp (see attached cost estimates) is at least \$10,000.00. This is substantial</u> cost for an unnecessary accessory to a facility that may never be used.

[X] The owner has made a **diligent investigation** into the costs of compliance with the code, but cannot find an efficient mode of compliance. Provide detailed cost estimates and, where appropriate, photographs. Cost estimates must include bids and quotes.

<u>The owner found that the most cost efficient design for the handicapped ramp is as</u> <u>shown on the attached drawings. The construction cost of the ramp as shown by the two</u> quotes received from two contractors is at least \$10,000.00.
