Mr. Compton entered a motion to approve the agenda as posted. The motion was seconded by Mr. Seijas. The motion passed unanimously with a vote of 15 to 0 in favor.

**Approval of Meeting Minutes for June 21, 2021:**

Chairman Schock asked for a motion to approve the minutes for June 21, 2021 as posted if there were no changes.

Mr. Schnellmann stated there was a typo and requested an amendment to have the typo corrected.

Mr. Mikkelson entered a motion to approve the minutes of the June 21, 2021 meeting as amended. Mr. Seijas seconded the motion. The motion passed unanimously with a vote of 15 to 0.

Mo Madani provided an overview of the information associated with this agenda item.

**Discuss Approach for Continually Tracking and Compiling Findings From Investigations of Champlain Towers.**

The Committee members discussed options for tracking and compiling information related to investigations of Champlain Towers.

Mo Madani stated that any information that is generated will be housed on the Building Code Information System on the webpage dedicated to the Hurricane Research Advisory Committee.

**Evaluate What Role, If Any, The Florida Building Code Could or Should Have Regarding Inspections and Maintenance of Existing High-Rise Residential Buildings and Other High-Rise Buildings As Appropriate.**

The Committee members discussed their views on the issue.

**Identification and Discussion of Next Steps.**

**A. Is Additional Research Necessary to Address Existing Data Gaps?**

The committee discussed their views and ideas on existing data gaps and additional research projects.

Jeff Blair summarized this discussion by providing a recommendation that the Commission approve a literature review/data collection of the building safety inspections/recertification inspections that have been completed in Miami-Dade and Broward Counties to date. Additional direction was given to staff to develop a scope of work and a source of funding for this project with a preference that the projects approved by the Commission in June 2021 be executed as soon as possible. Chairman Schock made the motion, Joe Belcher seconded the motion, the motion passed unanimously by a vote of 15-0.

## **B. Identification of Possible Briefings/Presentations from Other Experts**

Committee members provided their views on additional information and briefings they would like to receive. Committee members also expressed concerns about duplicating research projects that may already be underway by NIST and asked staff to reach out to NIST to get more information about NIST's projects.
