MY LITTLE ANGELS DAYCARE

Issue: Water closet mounting height in toilets for children.

Analysis: The applicant is requesting a waiver from providing water closets for children mounted at a height of 17 to 19 inches. The project is a new, 4,650 square foot one story concrete block structure. According to the applicant, cost is not the issue, but a concern for safety of small children having to use water closets designed for adults. Safety, rather than a financial burden is the concern.

Project Progress:

The project is under construction.

Items to be Waived:

Water closet mounting height from 17 to 19 inches, as required by Section 11-4.16.3 of the Accessibility Code.

11-4.16.3 Height. The height of water closets shall be 17 inches to 19 inches measured to the top of the toilet set. Seats shall not be sprung to return to a lifted position.

Waiver Criteria: There is no specific guidance for a waiver of this requirement in the code. The Commission's current rule, authorized in Section 553.512, Florida Statutes, provides criteria for granting waivers and allows consideration of unnecessary or extreme hardship to the applicant if the specific requirements were imposed.
