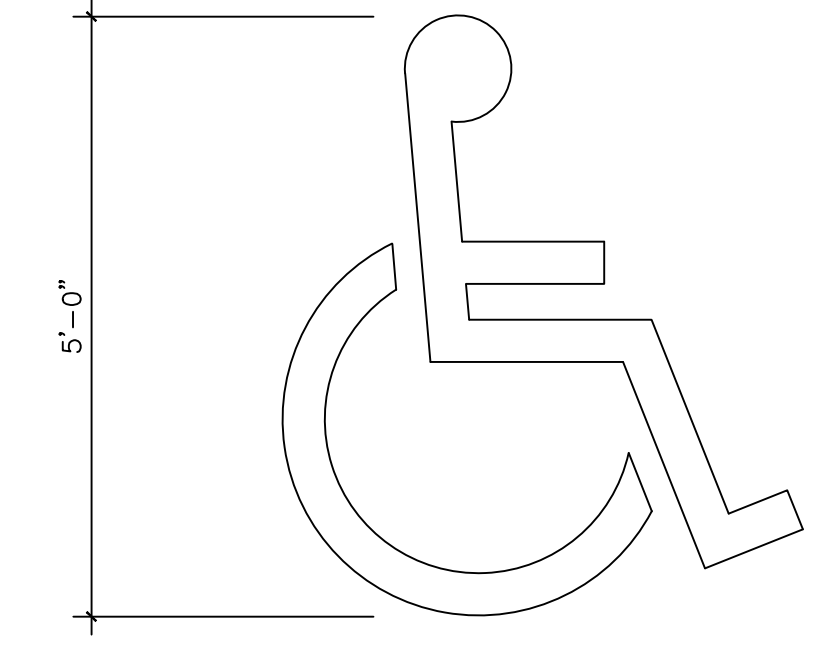

HANDICAP STALLS AND ACCESS AISLES SHALL BE LEVEL W/ SURFACE SLOPES NOT TO EXCEED 1:50 (2%) IN ALL DIRECTIONS.

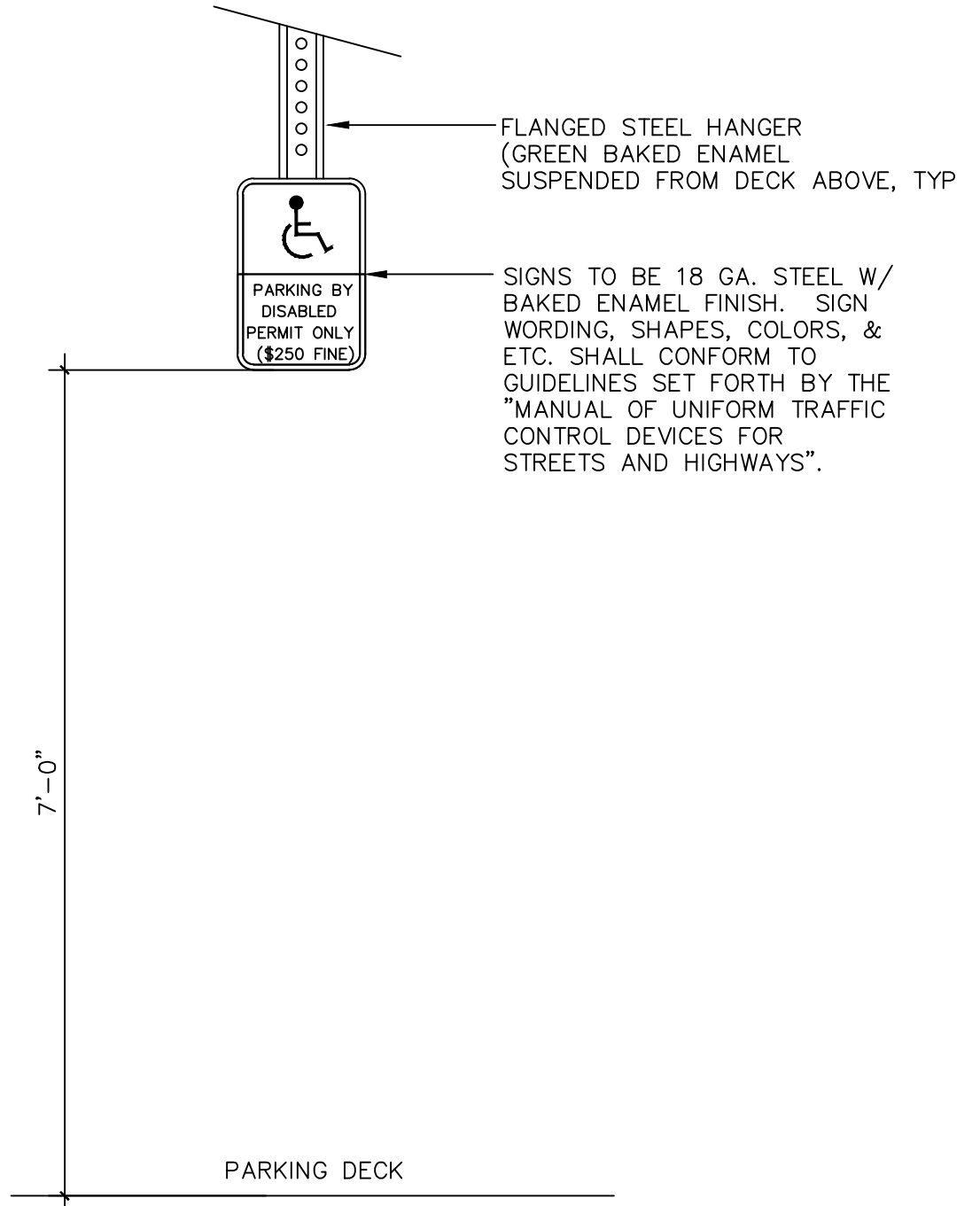
ACCESSIBLE ROUTES FROM THE END OF THE H/C ACCESS AISLES TO THE INSIDE ENTRY SHALL NOT EXCEED 1:20 (5%) SLOPES UNLESS OTHERWISE NOTED W/ NO ABRUPT CHANGES IN ELEVATION. SLOPES OF 1:12 SHALL NOT HAVE A VERTICAL RISE GREATER THAN 6" WITHOUT PRIOR APPROVAL.

EACH ACCESSIBLE SPACE MUST BE PROMINENTLY OUTLINED W/ BLUE PAINT & MUST BE REPAINTED AS NECESSARY TO BE CLEARLY DISTINGUISHABLE AS A PARKING SPACE DESIGNATED FOR PERSONS WHO HAVE DISABILITIES & MUST BE POSTED W/ A PERMANENT ABOVE-GRADE SIGN BEARING THE INTERNATL. SYMBOL OF ACCESSIBILITY MEETING THE REQUIREMENTS OF COLOR AND DESIGN APPROVED BY FDOT INDEX & THE CAPTION "PARKING BY DISABLED PERMIT ONLY". SUCH SIGN MUST INDICATE THE PENALTY FOR ILLEGAL USE OF THE SPACE.

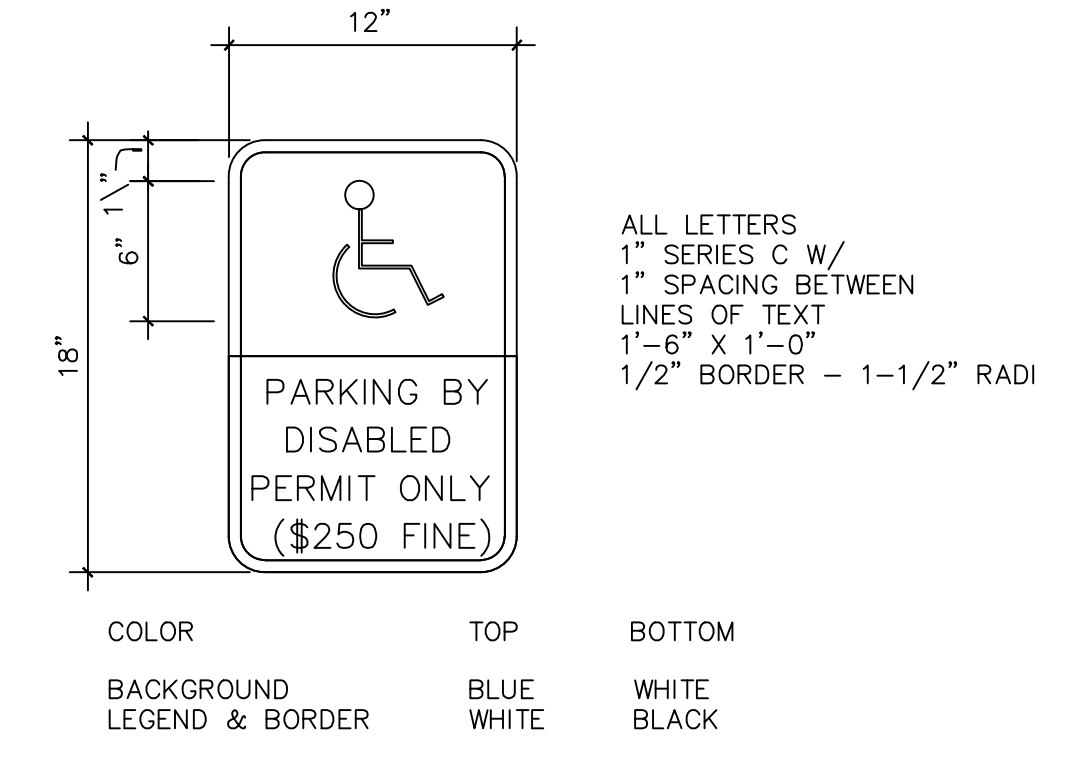

NOT TO SCALE



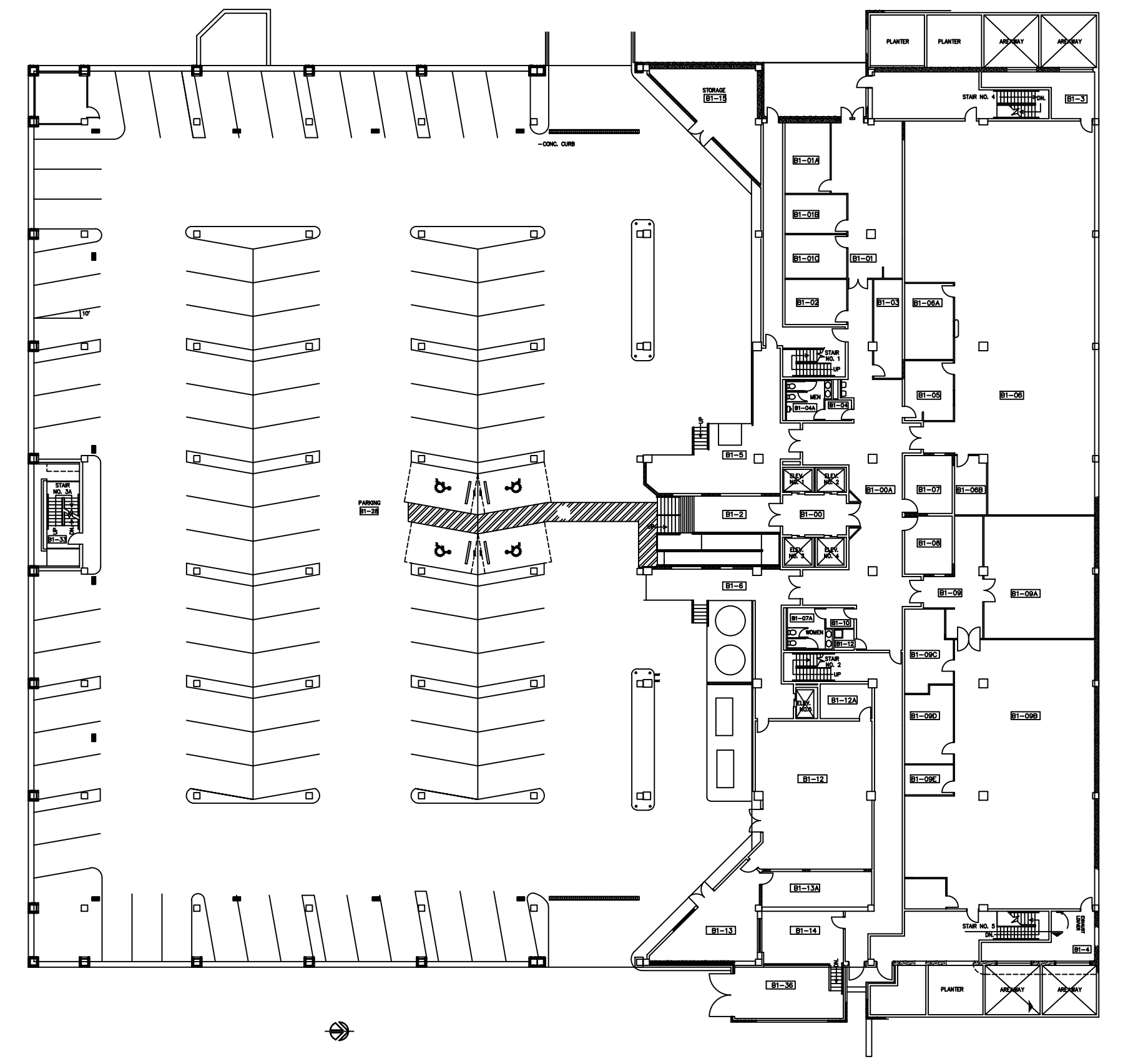
4 H/C SIGN MOUNTING HEIGHT
NOT TO SCALE



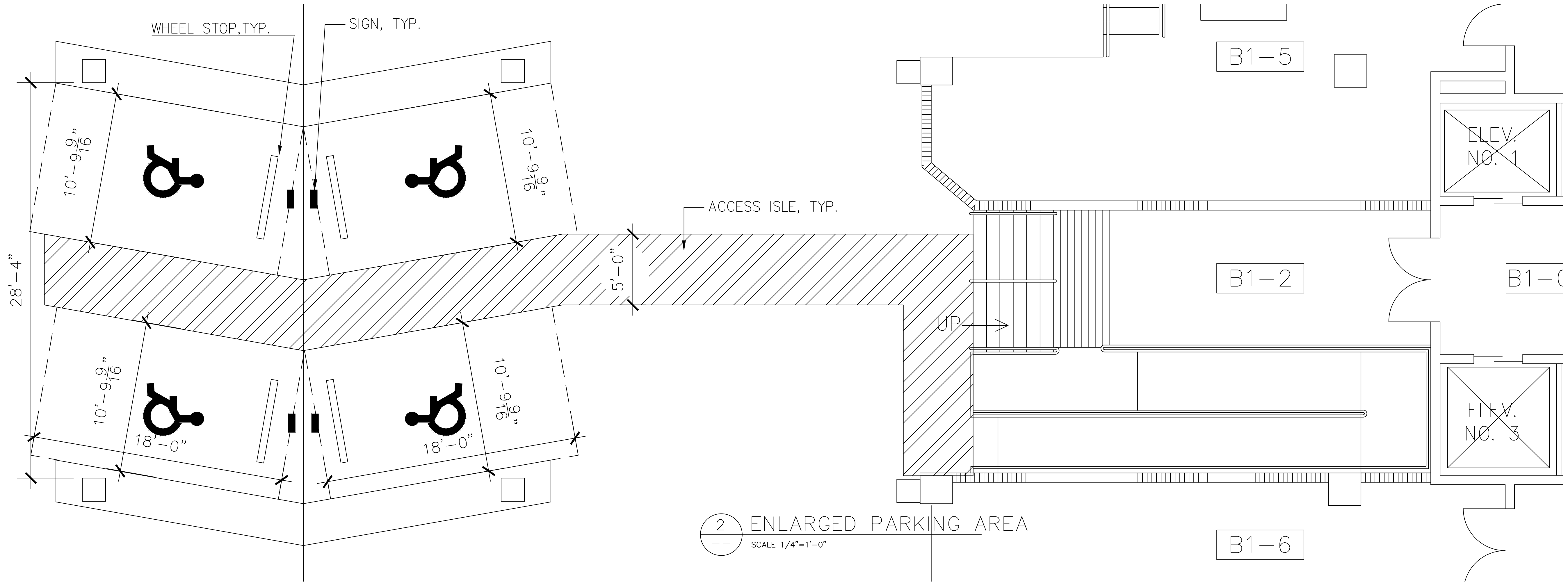
3 H/C PARKING SIGN
