## Plumbing Scope of Work (ADA)

Scope of work changed in order to comply with ADA requirements for those units. The layout of those apartments have been altered in order to comply. Therefore, bathroom layouts would have to be changed.

The scope of work shall include all plumbing necessary as needed for a complete system, including but not necessarily limited to:

- 1. Domestic cold and hot water piping system.
- 2. Sanitary drain and vent systems.
- 3. Plumbing fixtures and trim installations
- 4. Pressure and temperature relief from water heaters.
- 5. Supports and hangers.

New waste and Vent lines will connect to existing lines, and be made of the following material specification: Polyvinyl Chloride (PVC) Schedule #40 pipe. New water distribution lines will connect to the existing water lines and be made of the following material specification: Above Ground: "CPVC" Pipe. Below Ground: Polyvinyl Chloride (PVC) Schedule #40 pipe.

Plumbing contractor will include the concrete slab cutting based on a 5" think non-structural slab. All debris shall be removed by the contractor / owner. Back fill and concrete patching by others.

Plumbing contractor will do the digging for all trenches needed to install the drain and water lines, however, after the inspection has been approved the trenches will be backfilled by others.

All necessary plumbing fixture accessories shall be provided by Plumbing contractor such as stop valves, "P" traps, supports, hangers, etc. as required . All plumbing fixtures will have an individual shut off valve except the bathtubs and showers, and one main valve to control all water systems.

All plumbing fixtures, water heaters, and appliances shall be supplied by owner / general contractor. Plumbing contractor will provide the following installations:

12 - Floor mounted water closet installations

12 - Lavatory and faucet installations (Counter mounted faucets are included, Wall mounted faucets will require an additional charge)

12 - Vinyl shower pan lining including (1) control valve installation, (1) shower drain & (1) wall mounted shower head. Concrete sloped shower pitch by others.

- 12 Kitchen sink and faucet installation
- 12 Water heater installation
- 1 Mop sink with faucet installation.

The main drain line will be left 5' from the building wall. (THERE WILL BE AN ADDITIONAL CHARGE FROM THAT POINT TO THE SEWER CONNECTION)

The water service line will be left 5' from the building wall. (THERE WILL BE AN ADDITIONAL CHARGE FROM THAT POINT TO THE WATER METER CONNECTION)
