**Sobe Hostel** – **Waiver 523 - 235 Washington Avenue, Miami Beach 33139 - Issue:** Vertical accessibility to the upper lobby reception area and restrooms:

Mr. Benbow presented the waiver request with staff analysis and advised that the staff recommends granting the waiver application based on the grounds of the historical nature of the property.

Mr. Viksne entered a motion to recommend granting the request for a waiver for vertical accessibility to the upper lobby reception area and restrooms based on the grounds of the historical nature of the property. Ms. Klein seconded the motion. The motion passed unanimously with a vote of 4 to 0.

# Elizabeth Graham – Waiver 529 - 5137 N Florida Ave, Tampa 33603 - Issue: Vertical accessibility to the second floor:

Mr. Sellers presented the waiver request with staff analysis and advised that the staff recommends granting the waiver based on the grounds of technical infeasibility.

Mr. Viksne entered a motion to recommend granting the request for a waiver for vertical accessibility to the second floor based on the grounds of technical infeasibility. Ms. Klein seconded the motion. The motion passed unanimously with a vote of 4 to 0.

**1446 Ocean Drive Association, Inc.** – Waiver **486 - 1446 Ocean Drive, Miami Beach 33139 - Issue:** Vertical accessibility to the second and third floor:

Mr. Sellers advised that a request was received from the petitioner to withdraw the request for a waiver.

**Grand Cypress Redevelopment** – Waiver 513 - 1 Equestrian Drive, Orlando 32836 - Issue: Accessible parking space signage and marking requirements.

Mr. Vogel, Esq. presented the full waiver request with staff analysis and advised that the staff recommends denying the request for waiver from the specified accessible parking requirements, since the applicant has not met the necessary requirements in s. 553.512(1), Florida Statutes, for the Commission to grant a waiver.

Jennifer Calombo spoke on the striping requirements of the county and the request detail on behalf of the applicant.

Mr. Del Vecchio entered a motion to recommend denying the request for a waiver from the specified accessible parking requirements, since the applicant has not met the necessary requirements in s. 553.512(1), Florida Statutes, for the Commission to grant a waiver. Ms. Meyer seconded the motion. The motion passed unanimously with a vote of 4 to 0.
