## OVERVIEW OF COMMISSION'S KEY ACTIONS AND DECISIONS TUESDAY, OCTOBER 14, 2025

#### I. PLENARY SESSION SUMMARY AND OVERVIEW

The Commission conducted their October 14, 2025, Plenary Session as a web and teleconferencebased virtual meeting. At the August meeting the Commission considered and decided on Chair's issues and recommendations, Executive Director's announcements and discussions, applications for product and entity approvals, applications for accreditor and course approvals, application(s) for waiver(s) from accessibility requirements, a legal report, petition(s) for declaratory statement(s), and recommendations from the Commission's various committees and workgroups. Specific actions included voting unanimously to: 1) Approve the updated Workplan and Schedule for development of the 8th Edition (2023), Florida Building Code; 2) Approve the updated Workplan and Schedule for development of the 9th Edition (2026), Florida Building Code; 3) Adopt the TACs' Review and Recommendations to the Commission Process Regarding Comments Received on the Draft 9th Edition (2026), Florida Building Code; 4) Adopt the Commission's Review and Approval Process Regarding Comments Received on the Draft 9th Edition (2026), Florida Building Code; 5) Adopt the TACs' Review and Recommendations to the Commission Process Regarding Proposed Errata and Glitch Amendments for the 9th Edition (2026) Code Update; 6) Adopt the Commission's Review and Approval Process Regarding Proposed Errata and Glitch Amendments for the 9th Edition (2026) Code Update; 7) Approve Energy Code Compliance Software for the Florida Building Code, 8th Edition (2023), Energy Conservation, specifically Energy Gauge Summit 9.00 (v9.0), the updated Energy Gauge 8.0 (v8.0), for demonstrating compliance with commercial building energy requirements as follows: 1) Approval of EnergyGauge Summit 9.00, including the Generic Variable Refrigerant Flow (VRF) performance curves; 2) Approval of EnergyGauge Summit 9.00, including the manufacturer's VRF performance curves for the two specific systems; and 3) Approval of EnergyGauge Summit 9.00 to further include manufacturers' VRF performance curves, as available and verified following thorough vetting, and to authorize DBPR staff to approve non-consequential changes to the software as needed; and 8) Deny Petitioner's request for a Petition for Clarification and Rehearing, and to issue an Order to that effect.

Jeff Blair reviewed the proposed process and answered commissioner questions.

Following the opportunity provided for questions and answers, public comment, and Commission discussion, the Commission took the following action:

## XIX. APPROVAL OF ENERGY CODE COMPLIANCE SOFTWARE SUBMITTAL FOR DEMONSTRATING COMPLIANCE WITH THE 8<sup>TH</sup> EDITION (2023), FLORIDA BUILDING CODE, ENERGY CONSERVATION

The Chair explained that with adoption of each Edition of the Code the Commission is required to approve Energy Code compliance software for demonstrating compliance with the Updated Code.

For the October 2025 meeting the Commission was asked to approve an Updated Energy Compliance Software submittal for demonstrating compliance with the 8th Edition (2023) Florida Building Code – Energy Conservation, specifically Energy Gauge Summit 9.00 (v9.0), the updated Energy Gauge 8.0 (v8.0), for demonstrating compliance with commercial building energy requirements as follows: 1) Approval of EnergyGauge Summit 9.00, including the Generic Variable Refrigerant Flow (VRF) performance curves; 2) Approval of EnergyGauge Summit 9.00, including the manufacturer's VRF performance curves for the two specific systems; and 3) Approval of EnergyGauge Summit 9.00 to further include manufacturers' VRF performance curves, as available and verified following thorough vetting.

The Chair noted that the Energy TAC met on September 8, 2025 to review the submittal, and voted unanimously to recommend approval of the updated software per the submittal.

- 3. SOUTH PERFORMANCE LLC-WAIVER 735 4760 NW 17 Avenue, Miami 33142 *MOTION* The Commission voted unanimously, 13 0 in favor, to grant the waiver for vertical accessibility on the grounds of economic hardship.
- **4. OCEAN COAST RESORT WAIVER 604 –** 2707 Sadler Road., Fernandina Beach 32034 *MOTION* The Commission voted unanimously, 12 1 in favor, to grant the waiver for vertical accessibility on the grounds of technical infeasibility.
- 5. RONITA HOLDINGS, LLC WAIVER 740 1925 17th AVE, Vero beach 32960 *MOTION* The Commission voted unanimously, 13 0 in favor, to grant the waiver for vertical accessibility on the grounds of economic hardship.
- **6. 590-27 WAREHOUSE LLC WAIVER 743 –** 590 NW 27 Street, Miami 33127 *MOTION* The Commission voted unanimously, 14 0 in favor, to grant the waiver for vertical accessibility on the grounds of technical infeasibility.

#### XIII. LEGAL REPORT

Justin Vogel, Commission Legal Counsel, updated the Commission on outstanding legal matters relevant to the Commission. Justin reported that there were no outstanding legal matters to report for the August 2025 meeting. Justin also indicated, that as always, he will update the Commission as matters arise.

#### A. PETITION FOR CLARIFICATION AND REHEARING BY JACK A. BUTLER

The Chair reminded the Commission that that at the August meeting Mr. Butler submitted a Petition for Hearing Before the Florida Building Commission, and after hearing the Petition, the Commission voted unanimously to deny Petitioner's request for a hearing before the Commission and to likewise decline to refer the case to the Division of Administrative Hearings, and to issue an Order to that effect. The Chair explained that for the October 2025 meeting Mr. Butler returned and is requesting a Petition for Clarification and Rehearing, and requested that Jeff Blair review the procedural sequencing for the Commission's consideration of the Petition.

Jeff Blair reviewed the Procedural Sequencing the Commission used for consideration of the Petition as follows:

- 1) Justin Vogel, the Commission's legal counsel, will provide legal analysis as well as his legal opinion regarding the Commission's response to the Petition.

- 4) Petitioner's (Jack Butler, an individual) presentation of Petition for Clarification and Rehearing requesting the Commission refer Petitioner's challenge of specified Broward County local

- administrative amendments to the Division of Administrative Hearings (DOAH). [Five (5) Minutes collectively for Petitioner's side]
- 5) Commissioner Clarifying Questions for the Petitioner.
- 6) Respondent's (Broward County Board of Rules and Appeals (BORA) Charles Kramer) response to the Petition for Clarification and Rehearing. [Five (5) Minutes collectively for Respondent's side]
- 7) Commissioner Clarifying Questions for BORA.
- 8) Public Comment is limited to *Three (3) Minutes/Person*.
- 9) Commission Discussion and Decision Regarding Responding to the Petition for Clarification and Rehearing, and whether to refer Petitioner's challenge to specified Broward County local administrative amendments to DOAH.

Following the opportunity provided for questions and answers, public comment, and Commission discussion, the Commission took the following actions:

#### 2. DS 2025–028 by Timothy Krebs of Architect T.A. Krebs, LLC

**Motion** – The Commission voted unanimously, 14 - 0 in favor, to the Special Occupancy and Structural TACs' recommendation that the Commission adopt staff's analysis regarding the question(s) presented in the Petition.

#### 3. DS 2025-024 by Al Moschiner of Charleston Square Condominium Associations, Inc.

**Motion** – The Commission voted unanimously, 14 - 0 in favor, to adopt the Structural TAC's recommendation that the Commission adopt staff's analysis, regarding the question(s) presented in the Petition.

#### FLORIDA BUILDING COMMISSION HISTORY AND OVERVIEW

#### **HISTORY**

Following Hurricane Andrew in 1992 and Hurricane Opal in 1995, Florida experienced record-breaking insurance losses resulting in a crisis affecting every homeowner in the state. The Governor appointed a Building Code Study Commission, and the Florida Conflict Resolution Consortium designed and facilitated a two-year study and deliberation process with the 28 members representing a range of interests in the public and private sectors, through which the Commission evaluated the building code system.

The study revealed that building code adoption and enforcement was inconsistent throughout the state and even local codes thought to be the strongest proved inadequate when tested by major hurricane events. The consequences were devastation to lives and economies and a statewide property insurance crisis. The Commission recommended reform of the state building construction system which placed emphasis on uniformity and accountability. The Study Commission recommended a Florida Building Code System comprised of *Five Foundations for a Better Built Environment* described as: I. The Code; II. The Commission; III. Local Administration of the Code; IV. Strengthening Compliance and Enforcement; and, V. Product Approval.

The Legislature enacted the consensus recommendations into law in 1998. In late 1998, the FCRC Consensus Center at Florida State University was asked by the Commission's chair to assist the newly created Florida Building Commission in its effort to build consensus for a uniform building code proposal. A comprehensive and transparent consensus building process was put in place that included designing and facilitating meetings of 12 balanced technical advisory groups of 11 members each appointed by the Commission, as well as the Commission's meetings. Facilitated Solutions, LLC continues to work with the Commission by providing facilitation and consensus-building services using the same process and facilitator.

#### **OVERVIEW**

COMMISSION REPRESENTATION. The Florida Building Commission has consisted of as many as 27 members, and since January 1, 2021 is a 19-member building construction industry representative stakeholder group who successfully created, implemented, maintains, and updates the new statewide Florida Building Code. The Commission is comprised of 19 members appointed by the Governor to represent specific stakeholder groups. They are as follows: three municipal, county, or district code officials; an architect; a persons with disabilities representative; a structural engineer; an air conditioning or mechanical contractor, or mechanical engineer; an electrical contractor or electrical engineer; a manufactured buildings industry representative; a building products manufacturing industry representative; an insurance industry representative; a certified general or building contractor; a swimming pool contractor; a plumbing contractor; a roofing or sheet metal contractor; a swimming pool contractor; a building products manufacturing industry representative; a natural gas system distribution representative; and the Governor's Chief Resilience Officer or designee.

**CONSENSUS PROCESS.** The Florida Building Commission (FBC) seeks to develop consensus decisions on its recommendations and policy decisions. General consensus is a participatory process whereby, on matters of substance, the members strive for agreements which all of the members can accept, support, live with or agree not to oppose. In instances where, after vigorously exploring possible ways to enhance the members' support for the final decision on substantive decisions, and the Commission finds that 100 percent acceptance or support is not achievable, final decisions require at least 75 percent favorable vote of all members present and voting. This super majority decision rule underscores the importance of actively developing consensus throughout the process on substantive issues with the participation of all members and which all can live with and support.

The Commission's consensus process is conducted as an open public process with multiple opportunities for the public to provide input to the Commission on substantive issues. At each Commission meeting, the public is invited to speak during the public comment opportunity provided for each substantive issue under consideration, as well as general public comment periods provided at the end of each meeting. In addition, most substantive issues before the Commission go through a technical advisory committee review or workgroup process where consensus recommendations are developed by appointed representative stakeholder interests, providing extensive opportunities for public input. In addition many of the Commission's decisions require rule development to implement, affording additional entry points for public input.

Since its formation in July of 1998, the Commission has demonstrated a commitment to working with affected interests to build consensus on complex issues. The adoption of the first edition of the Florida Building Code (2001 Edition), developed from September 1998 through January of 2001, involved 27 Commission meetings, dozens of facilitated public workshops and hundreds of TAC meetings. The Commission has consistently worked with all affected interests to build the best possible consensus-based decisions for the citizens of Florida. Through its committees and workgroups comprised of experts, the Commission has always developed its decisions based on the results of the best engineering and science available. Since 1999 the Commission has convened 70 special issue stakeholder workgroups to develop broad based consensus recommendations on issues of concern to stakeholders. Although the Code is by law a minimum building code, the Florida Building Code is the strongest consensus and science based building code in the country. The Insurance Institute for Business and Home Safety (IBHS) ranked the Florida Building Code as number one in their 2012, 2018, and 2021 assessments of residential building code enforcement systems for life safety and property protection in hurricane prone regions.

In summary, the Florida Building Commission provides a forum for stakeholders representing key interests to participate in a consensus-building process where issues affecting the construction industry are discussed and evaluated on their technical merits and cost-benefits to the citizens of the State of Florida. In addition, as a result of the Commission's proven consensus-building process and success in developing consensus on tough issues, the Florida Legislature frequently assigns policy issues to the Commission for evaluation and implementation.
