Staff Analysis:

Question:

When the smoke detector and the refrigerant leak detector are both activated, should the 606.4 shut down requirement supersede the ASHRAE run requirement?

Answer:

Option #1/Petitioner:

I believe the answer to the question is that 606.4 supersedes ASHRAE 15. The condition being ameliorated by 606.4 suggests that a fire is already present, whereas ASHRAE 15's requirements are attempts to prevent fire or mitigate its spread. The code mandate that deals with an extant fire should take precedence over the mandate that's intended to prevent fire.

Option #2/Staff:

The answer to the Petitioner's question is yes. Pursuant to section 102.4.1 of the Florida Building Code, Building, 8th Edition (2023), where conflicts occur between provisions of the FBC and referenced codes and standards, the provisions of the Florida Building Code shall apply. Therefore, for the project in question, when the smoke detector and the refrigerant leak detector are both activated, the shutdown requirement of section 606.4 of the Florida Building Code, Mechanical, 8th Edition (2023) supersedes that of the ASHRAE 15 run requirement.
