**Set Agenda:** Mr. Melick moved to approve the agenda as published, and was seconded by Mr. Schneider. The vote of the TAC was unanimous sin favor of the motion.

Ms. Mignardi suggested, and the TAC concurred, that it was unreasonable to expect a professional charette to be organized in time for the December, and recommended holding the charette in conjunction with the February 2005 Commission meeting.

**Discussion of Proposed Federal ADAAG Guidelines**: The Department of Justice will receive public comment on the proposed new guidelines until January 26, 2005. Each TAC members is to make recommendations and submit them to staff at least two weeks prior to the December meeting so they may be compiled and distributed.

Staff is to obtain copies of Chapter 11 of the 2003 International Building Code and provide them to the TAC members.

**Set Agenda for December Meeting**: The principal items to be discussed in December will be a review of the comments on the proposed ADAAG guidelines and an ongoing discussion of incorporating the new ADAAG into the Florida code. Mr. Gross asked Ms. Smith to see if Jeff Blair, meeting facilitator, could be present at the December meeting to assist with discussion of the proposed new ADAAG.
