Approved revisions requested at August 2004 Education TAC meeting:

- a) 9B-70.002 (3) In the event the Commission identifies areas or topics of advanced Building Code education with insufficient number of courses available through existing resources, the Commission shall report the areas or topics to the appropriate licensing board. If additional courses do not become available within _____ months of notification to the licensing board, the Commission will develop a minimum of one (1) course that will be made available to training providers.
- b) 9B-70.002(3)(d)The accreditor shall also provide a certification of independence that attests the person or entity does not have, nor does it intend to acquire nor will acquire, a financial interest in the training provider seeking accreditation.
- c) 9B-70.002(3)(e)......The application shall be reviewed and action taken on the accreditation and approval of the materials at the regularly scheduled meeting of the Florida Building Commission which occurs more than 30 days from the date the accreditation number is assigned.
