Dear Chairman Schock,

As a member of the Florida Home Builders Association, I am writing to urge the Florida Building Commission to retain the current definition of Wind-borne Debris Regions in the Florida Building Code - Building and Residential 8th Edition.

In the upcoming changes set to take effect in 2024, the inclusion of inland lakes will significantly impact a large number of lakes that meet the criteria in this definition, placing an undue burden on Floridians, despite no proven need for this change.

Due to Florida being a much larger hurricane-prone region, the change to ASCE7-22 will have a more considerable impact. However, the FEMA Mitigation Assessment Team (MAT) reports make no mention of windborne debris damage around inland lake areas. Additionally, MAT reports for Hurricanes Katrina, Charley, Irma, and Michael do not cite any windborne debris damage around inland lake areas.

Throughout the code cycle, there was no discussion of the impact of this change by the Structural TAC nor the Florida Building Commission. While proponents of this change to both the Florida Building Code and the International Codes have stated that it will not increase or decrease the cost of construction, builders across the state will see an increase in costs for windows and doors.

A builder's costs for windows and doors in Lake County will nearly double from \$12,361 to \$24,874. Bear in mind, for every \$1,000 increase in the median home price in Florida, 9,573 families are priced out of the mortgage market. That is 9,573 families that would qualify for a mortgage before this increase but not after.
