- 2. Product anchors shall be as listed and spaced as shown on details. Anchor embedment to base material shall be beyond wall dressing or stucco.
- 3. When used in the "HVHZ", this product complies with Section 1626 of the Florida Building Code and does not require and impact resistant covering.
- 4. For 2x stud framing construction, anchoring of these units shall be the same as that shown for 2x buck masonry construction.
- 5. Site conditions that deviate from the details of drawing FL-15450.3 require further engineering analysis by a licensed engineer or registered architect.
- 6. See drawing FL-15450.3 for size and design pressure limitations.
