

Through Frame Installation:

- A. For wood substrates use (1) #14 Wood Screw type anchor per location of sufficient length to achieve a minimum embedment of 1.50" into the wood substrate.
- B. For concrete or masonry substrate where one by (1X), non-structural, wood bucking is employed, use (1) 5/16" diameter Elco UltraCon concrete screw anchor per location of sufficient length to achieve minimum embedment of 1.75" into concrete or masonry.
- C. For concrete or masonry substrate where wood bucking is NOT employed, use (1) 5/16" diameter Elco UltraCon type concrete screw anchors per location of sufficient length to achieve minimum embedment of 1.75" into concrete or masonry.
- D. For steel substrate, use (1) 1/4" Teks Select Screw anchor per location of sufficient length to achieve minimum three threads of penetration beyond steel structure.
- E. For aluminum substrate, use (1) 1/4" Teks Select Screw anchor per location of sufficient length to achieve minimum three threads of penetration beyond aluminum structure.

Refer to Installation Instructions (CGS089) for anchor spacing and more details of the installation requirements.
