- Product anchors shall be as listed and spaced as shown on details. Anchor embedment to base material shall be beyond wall dressing or stucco.
- When used in areas requiring wind borne debris protection, this product complies with Section 1609.1.2 of the FBC and does not require an impact resistant covering. This product meets missile level "D" and includes Wind Zone 4 as defined in ASTM E1996 and Section 1609.1.2.2 of the FBC.
- 4. Site conditions that deviate from the details of drawing FL 18506.8 require further engineering analysis by a licensed engineer or registered architect.
- 5. See drawing FL-18506.8 for size and design pressure limitations.
