- 3. When used in areas requiring wind borne debris protection, this product is complies with FBC Sections 1609.1.2 & R301.2.1.2 and does not require an impact resistant covering. This product meets missle level "D" and includes Wind Zone 3 as definded in ASTM E1996 and FBC Sections 1609.1.2.2 & R301.2.1.2.1.
- 4. Site conditions that deviate from the details of drawing FL-26906.2 require further engineering analysis by a licensed engineer or registered architect.
